Zoning Application #26-04. An application requesting an amendment to a special use permit for a planned unit development to allow the construction and use of a one-story, 515 square foot coffee stand with a separate 238 square foot cooler/ storage building on a leased parcel of land in the Rice Lake Square Shopping Center parking lot between the former Houlihan's restaurant at 321 Rice Lake Square and Studio Movie Grill at 301 Rice Lake Square. The property is zoned C-5 Planned Commercial District.

The application is further requesting a special use permit to Article 20.3 of the Wheaton Zoning Ordinance to allow sales or service directly to customers in vehicles.

The application has been submitted by Who Brew IL II LLC, 100 Powell Place, Suite 1320, Nashville, TN 37204 on behalf of the property owner, Core Rice Lake LLC, PO Box 1243, Northbrook, IL 60065.
