## WHEATON LOCAL TOBACCO COMMISSION MEETING MINUTES

WHEATON CITY HALL, 303 W WESLEY STREET, WHEATON, ILLINOIS 60187

June 12, 2025

### I. CALL TO ORDER AND ROLL CALL

Chair Pearse called the June 12, 2025 meeting of the Local Tobacco Control Commission to order at 7:32 P.M. in the City Council Chambers of the Wheaton City Hall, 303 West Wesley Street.

Upon roll call, the following were present: Commissioner Laird, Chair Pearse and Commissioner Whitmer. Absent: Commissioner Brown and Commissioner Taylor. City Staff Present: James P. Kozik, Director of Planning and Economic Development.

### II. PUBLIC COMMENT

There was no public comment.

### III. APPROVAL OF MINUTES – June 20, 2024

Hearing no questions or comments, Commissioner Laird moved and Commissioner Whitmer seconded a motion to recommend approval of the minutes of the June 20, 2024 Local Tobacco Control Commission meeting as submitted. On a voice vote, all voted aye.

### IV. NEW BUSINESS

#### Violation Hearing – Wheaton Convenience LLC d/b/a CA Convenience, 1026 College Avenue

Chair Pearse called the public hearing to order. Chair Pearse stated that the public hearing is to review evidence relating to allegations of a violation of the Tobacco Control Ordinance by Wheaton Convenience LLC d/b/a CA Convenience whereby tobacco products were sold to a person under the age of 21.

Mr. Kozik stated that in their witness of the tobacco sale, the Wheaton Police observed that the salesclerk did not ask the decoy for identification and that the licensee has entered a plea of guilty to the allegations. A Tobacco License holder since 2023, Mr. Kozik stated that this is Wheaton Convenience LLC d/b/a CA Convenience's second violation of Section 26-135 of the City Code with a fine levied of \$200 in 2023.

Mr. Umer Masoom, manager, was present to explain the circumstances surrounding the violation. Mr. Masoom stated that the clerk who committed the violation is no longer in his employ. Mr. Masoom stated that it is now his business's policy to card everyone wishing to purchase tobacco product regardless of age.

Hearing no further questions or comments the public hearing was closed.

Violation Hearing – Emma's Groceries, Inc d/b/a Wheaton Food Mart & Tobacco, 728 S. Lorraine Road

Chair Pearse called the public hearing to order. Chair Pearse stated that the public hearing is to review evidence relating to allegations of a violation of the Tobacco Control Ordinance by Emma's Groceries, Inc d/b/a Wheaton Food Mart & Tobacco whereby tobacco products were sold to a person under the age of 21.

Mr. Kozik stated that in their witness of the tobacco sale, the Wheaton Police observed that the salesclerk asked the decoy for identification and that the licensee has entered a plea of guilty to the allegations. A Tobacco License holder since 2023, Mr. Kozik stated that this is Emma's Groceries, Inc d/b/a Wheaton Food Mart & Tobacco's second violation of Section 26-135 of the City Code with a fine levied of \$200 in 2023.

Ms. Emma Santos-Salazar, owner, was present to explain the circumstances surrounding the violation. Ms. Santos-Salazar stated her sister, who was taking care of the business while she was attending to family matters in Mexico, committed the violation. Ms. Santos-Salazar stated that normally she is the only person who works at the store and that she asks for everyone's ID.

Hearing no further questions or comments the public hearing was closed.

Violation Hearing – Osco Drug #3230 – 30 Danada Square West

Chair Pearse called the public hearing to order. Chair Pearse stated that the public hearing is to review evidence relating to allegations of a violation of the Tobacco Control Ordinance Osco Drug #3230 whereby tobacco products were sold to a person under the age of 21.

Mr. Kozik stated that in their witness of the tobacco sale, the Wheaton Police observed that the salesclerk asked the decoy for identification and that the licensee has entered a plea of guilty to the allegations. A Tobacco License holder since the late 1980's, Mr. Kozik stated that this is Osco Drug #3230's fourth violation of Section 26-135 of the City Code with fines levied of \$75 in 1993, \$75 in 1994 and \$300 in 2015.

Store Manager Cale Clay and Corporate Officer Johanna Chacon were present to explain the circumstances surrounding the violation. Mr. Clay stated the clerk did not follow protocol when she made the sale. Mr. Clay stated that the clerk received a three day suspension and was retrained on proper procedures upon her return.

Hearing no further questions or comments the public hearing was closed.

At 7:48 P.M. Commissioner Whitmer then moved and Commissioner Laird seconded the motion to go into Executive Session pursuant to the Illinois Compiled Statutes 5ILCS 120/2 (c) (4) On a voice vote, all voted aye. At approximately 7:55 P.M. the Commission returned to open session.

Following an admonishment of the licensees, Chair Pro-Tem Taylor stated the Commission will be recommending a \$500 fine for all three licensees to the Tobacco Commissioner.

## MEMORANDUM

**SUBJECT:** Violation Hearing – Puff Place Smoke Shop, LLC d/b/a Puff Place Smoke Shop - 945 Geneva Road

### Action

The Local Tobacco Commission will convene a public hearing on February 12, 2026 to review evidence relating to allegations of a violation of the Tobacco Control Ordinance by Puff Place Smoke Shop, LLC d/b/a Puff Place Smoke Shop whereby tobacco products were sold without having first obtained a tobacco dealer's license.

### Background

Puff Place Smoke Shop, LLC d/b/a Puff Place Smoke Shop at 945 Geneva Road held a tobacco dealer's license in 2025. Despite numerous attempts to reach the licensee about renewing their license for 2026, they did not do so.

On Monday, January 5, 2026 a Wheaton undercover detective completed a compliance check at Puff Place, 945 W. Geneva Rd. The detective was able to purchase a Lost Mary Blue Razz Ice vape cartridge from the business and he subsequently issued the employee who sold the vape, identified as Benyamin Daraji, a DACRA citation, number 0091-000012, for the tobacco ordinance violation. Mr. Daraji, who is also the licensee, was sent notice of his alleged City Code violation. Mr. Daraji did not respond to the notice and did not provide a notification of plea. As a result, the hearing will be held in absentia.

Mr. Daraji no longer owns and operates the business. A new owner/operator has received an Occupancy Permit and Tobacco License to operate a new tobacco store at the former Puff Place location.

Section 26-143 (b) of the City Code states the tobacco commissioner, after a hearing conducted by the tobacco commission, may suspend or revoke any license issued under the provisions of this article if he determines that the licensee has violated any of the provisions of this article.

In lieu of suspension or revocation of the license, the tobacco commissioner may instead levy a fine on the licensee. The fine imposed shall not exceed \$500 for each violation. The licensee shall also pay the costs of the hearing held before the tobacco commission.

## Narrative Information

On January 5, 2026, Lt. Potter assigned myself and Detective Freeman to conduct a tobacco compliance check of Puff Place Smoke Shop, 945 W. Geneva Rd. Wheaton, IL 60187. It was related to myself and Detective Freeman that Puff Place, also known as BV CORNER SMOKE AND VAPE, based on the sign placed on the business, had let their City of Wheaton tobacco license expire effective January 1, 2026, and had yet to renew their license after numerous reminders via email from Wheaton City Clerk Andrea Rosedale. Lt. Potter provided us \$20 petty cash for us to use in an attempt to purchase a tobacco product from BV CORNER SMOKE AND VAPE.

On January 5, 2026, at approximately 4:00 PM, Detective Freeman and I arrived at 945 W. Geneva Rd at which time Detective Freeman went into

BV CORNER SMOKE AND VAPE in an undercover capacity and purchased (1) Lost Mary Blue Razz Ice vape cartridge for \$14. Detective Freeman then returned to the vehicle and showed me the vape cartridge and provided a description of the person who sold him the vape (short middle eastern male with a beard) and that he was the only person inside the store. I in turn took the vape cartridge from Detective Freeman and returned to BV CORNER SMOKE AND VAPE.

Upon entering the store, I was greeted by the only person in the store and the person who fit Detective Freeman's description, now known as Benyamin Daraji. I asked Benyamin if he just sold the Lost Mary Blue Razz Ice vape cartridge I was holding and he said yes. I informed Benyamin he sold the vape cartridge to a police officer and that he was not allowed to due to BV CORNER SMOKE AND VAPE'S tobacco license being expired. Benyamin stated he had a tobacco license and provided me with an expired City of Wheaton tobacco license with an expiration date of 12/31/2025. I informed Benyamin the license was currently expired and that he could no longer sell tobacco from the store until he renewed his tobacco license with the City of Wheaton.

Benyamin returned the money Detective Freeman used to purchase the Lost Mary Blue Razz Ice vape cartridge and I returned the vape back to him. I informed Benyamin that I would have to issue him a City of Wheaton Ordinance Violation, which I would serve to him at a later date. Benyamin stated he understood, at which time I left the store.

On January 6, 2026, I drafted a City of Wheaton Ordinance Violation Notice via DACRA under citation number 0091-000012 and served it to Benyamin Daraji. The DACRA citation showed a must appear court date of 02/11/26 at 6:30 PM, 303 W. Wesley Street Wheaton, IL 60187.

I also attached to this police report a copy of the numerous emails from City Clerk Andrea Rosedale to Benyamin Daraji informing him of his tobacco license expiring dating back to October 2025, as well as a City of Wheaton letterhead letter explaining the process of renewing the tobacco license and the actual application to renew.
