City Manager Dzugan stated a public hearing was held on November 28, 2022 for an amendment to an annexation agreement for 1501 Waldorth Court. He detailed the amendment requests a front yard set back of 30 versus 40.4 feet from the east adjacent to Orchard Road, and a rear yard setback of 20 feet in lieu of the required 25 feet from the west property line. He highlighted the proposed ordinance requires five votes to be passed.

Mr. Gary Van Prooyen, property owner of 1501 Waldorth Court, thanked City Council members for consideration of the amendment to the annexation agreement. He detailed his intent to retire in the proposed home and stated the modifications are necessary to allow for a neighborhood enhancing, single floor living space, which will provide an improved layout scenario for surrounding neighbors.
