## II. Public Hearing – Vacation Request, Wheaton Sanitary District, & Shaffner Road Right-of-Way

### a. Staff Comment

Assistant City Manager Duguay reviewed the Wheaton Sanitary District's petition submittal requesting that the City vacate a certain right-of-way (ROW) known as the Shaffner Road ROW lying generally east of Shaffner & Mack Roads and west of their property. He stated that the City previously vacated the Shaffner Road ROW; that area north and west of the Atten Park softball fields, north to where Shaffner Road bends to become Mack Road. He also stated that ComEd and AT&T wish to keep an easement over the entire area. Therefore, in accordance with City Code 58-38, there is no compensation required except to reimburse the City with associated expenses.

In response to a question from Mayor Suess, Wheaton Sanitary District Executive Director Matt Larson stated the Sanitary District is planning to complete necessary work related to bank stabilization for the creek that runs through their property and adjacent to the City ROW and Shaffner Road. He stated the project aims to minimize and ideally eliminate the erosion of the banks and increase water quality in the area. He stated at this time the Wheaton Sanitary District does not have immediate plans to utilize the land, however, it makes sense to make it a part of the District's property.
