Please note that with the enclosed application for a Special Event Permit for the Wheaton Wine Walk scheduled for August 10, 2017, I have not included the certificates of general liability and the liquor liability for this event. The Downtown Wheaton Association is waiting for the renewal of insurance for general liability (our current policy expires August 6, 2017). I have instructed our insurance broker to expedite the renewal of this policy well in advance of August, 2017 in order to cover the August 10<sup>th</sup> event.

In addition to the general liability, we have instructed our broker to proceed with the purchase of the liquor liability insurance (dram shop) to cover this event.

Once our supporting documents are in hand, we will deliver these to your office.

For the sake of time and the need to be on the agenda for the Wheaton Liquor Commission, I have submitted the enclosed application for review. Please note that although the Wheaton Wine Walk is a one day event, on August 10<sup>th</sup>, we would like to request that the permit be issued to cover Wednesday, August 9<sup>th</sup> and Thursday, August 10<sup>th</sup>. The additional date on the permit would allow our wine distributor to deliver the wine to the tasting stations the day before the event- without the additional date on the permit, the distributor cannot make the earlier delivery.

Please let me know if the request for a two-day permit is allowable.

Describe Event: Ticketed wine tasting event. The DWA sells tasting tickets (\$35 for 12- one ounce tastings) to the public. Tickets are sold on line and at the check in tent at Martin Memorial Plaza on Aug. 10. 2016. All ticket holders must check in at Martin Memorial Plaza to be carded (must be 21 years or older); receive their actual tasting tickets, one souvenir wine glass and a walking map of all tasting locations. Tasting locations will be inside participating restaurants and selected retailers. The DWA will be purchasing the wine and distributing it to the tasting stations.

Each station will have one to two wines offered for tastings. Each restaurant and retailer is required to have a Basset trained person (21 years or older) as the server. A special wine stopper that only allows for 1 ounce pours will be in each opened bottle. The server will be responsible for marking off each tasting on the participant's tasting ticket.

All tastings must be consumed inside the business premises. Signs will be posted inside the doorways noting that all tastings must be finished inside- no alcohol allowed outside. At each tasting station, a tray of appetizers will be available to participants to enjoy.

A free trolley will circulate in the downtown area to provide transportation from the north side of the downtown to the two tasting locations on the south side of downtown-The Perfect Thing, Adelle's and Wheaton Center Apartments.

One jazz ensemble and one acoustical musical performers will be located on the sidewalks to perform during the wine event. The locations at this time will be at the northeast corner of Hale and Front, at the northeast corner of Hale and Wesley.

Glass rinsing stations (portable water coolers and buckets- to catch the water) will be located on the sidewalk at Main and Front, Hale and Front, at Hale and Wesley and at the trolley stop at Adelle's Restaurant on Liberty Street.

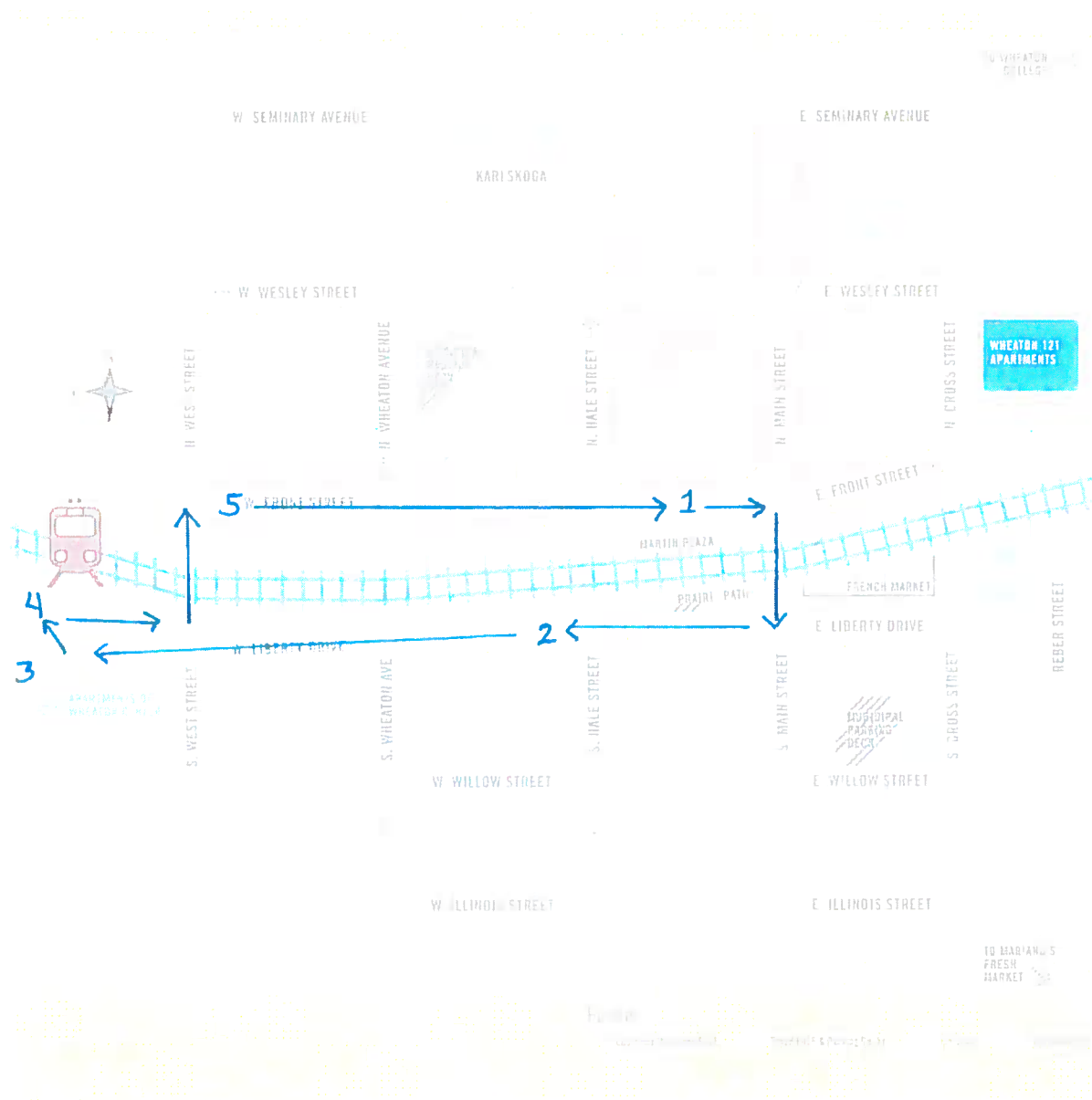
