RESOLUTION R-29-06
A RESOLUTION AUTHORIZING THE DISPOSAL
OF CERTAIN SURPLUS PROPERTY

WHEREAS, Section 2-506 of the Wheaton City Code sets forth a procedure for disposal of property found to be surplus; and

WHEREAS, a request to dispose of property described in Exhibit "A" attached hereto and made a part hereof by reference, has been submitted; and

WHEREAS, the City Manager has approved said request and forwarded it to the City Council for authorization.


NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that the City Manager is authorized to proceed with disposal of said surplus property in compliance with the provisions of Section 2-506, and is authorized to either advertise for bids, contact directly likely purchasers, and to take other such responsible means to cause the most profitable recovery to the City of Wheaton, or, if unable to sell said property, give said property to any not-for-profit corporation, organization, or entity having its principal place of business or doing a substantial amount of business in the city, at no charge to the recipient or to junk the property at the least possible cost to the city. The City Manager shall report back to the City Council in compliance with paragraph (i) of said Section when all or a majority of said property has been disposed of.

Subject: ***Disposal Authorization***



I am seeking disposal authorization for the Traffic Speed Trailer. It was purchased in 1998 and is no longer serviceable to us. The trailer is rusted and in need of welding and re-painting. The individual LED lights have dimmed with age and are of little use. The electrical system is out of service and will require significant funds to repair. The original cost of the trailer was \$10,175. Repair costs are estimated at \$4,000 to bring the unit into service however we have transitioned from this device to the more effective speed display signs.

I recommend authorization to offer the device to other law enforcement agencies or like entities or offer it at auction, in an effort to re-coup as much value as possible.
