RESOLUTION R-33-06


A RESOLUTION APPROVING ELITE PROPERTIES CONSOLIDATION (1621 WEST YORK LANE)



Elite Properties Consolidation
1621 West York Lane

Legal Description

LOT 5 AND THAT PART OF LOT 4, DESCRIBED AS FOLLOWS: BEGINNING AT THE SOUTHWESTERLY (BEING ALSO THE MOST SOUTHERLY) CORNER OF SAID LOT 4; AND RUNNING THENCE EAST ON THE SOUTH LINE OF SAID LOT, 43.70 FEET TO A POINT OF TANGENCY; THENCE NORTHEASTERLY ON A CURVE WITH A RADIUS OF 25.0 FEET, AN ARC DISTANCE OF 18.40 FEET; THENCE NORTHWESTERLY ON A STRAIGHT LINE FOR A DISTANCE OF 186.88 FEET TO A POINT ON THE WESTERLY LINE OF SAID LOT: SAID POINT IS LOCATED MIDWAY BETWEEN THE MOST NORTHERLY AND WESTERLY CORNERS OF SAID LOT 4; THENCE SOUTHERLY ON SAID WESTERLY LINE, 9.15 FEET TO THE MOST WESTERLY CORNER OF SAID LOT; THENCE SOUTHEASTERLY ON THE SOUTHWESTERLY LINE OF SAID LOT 160.4 FEET TO THE PLACE OF BEGINNING, ALL IS IN BLOCK 4 IN ARTHUR T. MC INTOSH AND COMPANY'S LORRAINE ROAD SUBDIVISION IN THE SOUTH HALF OF SECTION 15, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN DU PAGE COUNTY, ILLINOIS.
