

## **RESOLUTION R-29-08**

### **A RESOLUTION APPROVING THE FINAL PLAT OF 819 UNIVERSITY PLACE RESUBDIVISION**


WHEREAS, the Final Plat of 819 University Place Resubdivision has been submitted to and reviewed by the Wheaton City staff (the property is described on Exhibit "A" attached to this resolution); and the Wheaton City staff has recommended that the plat of resubdivision be approved subject to the following conditions, restrictions, and requirements.

1. The following variances from the City's Subdivision Control Regulations are granted:
  - A. Section 62-212. Minimum residential lot area and frontage – generally. A lot frontage of 68.65 feet, in lieu of 70 feet, is permitted for Lot 1.
  - B. Section 62-213. Minimum residential lot area and frontage – corner lots. A lot area of 10,230.93 square feet, in lieu of the required minimum area of 12,000 square feet, and a lot frontage of 68.65 feet, in lieu of 90 feet, is permitted for Lot 2.
  - C. Section 62-286. Street lighting; Section 62-290. Pavement edging; and Section 62-178. Pavement width. Due to the small size of the subdivision and the absence of full street improvements in the immediate surrounding area of the resubdivision, no additional street improvements need to be constructed within the Webster Street right-of-way adjacent to the resubdivision.
2. The developer shall construct a public sidewalk along the north right-of-way of University Place from the existing sidewalk terminus west of Lot 2 to Webster Street.
3. In lieu of constructing public sidewalk along Webster Street, the developer shall contribute the cost of installing said public sidewalk pursuant to Section 58-74 of the City Code.
4. The house and driveway orientation for Lot 1 shall be such that the driveway shall be located closer to the south lot line than the north lot line of Lot 1.
5. The developer shall extend a storm sewer service line along the common lot line of Lot 1 and Lot 2 to serve the sump pump discharges of the new homes.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council, of the City of Wheaton, Illinois, that the Final Plat of 819 University Place Resubdivision as prepared by, Stacy L. Ferguson, an Illinois Professional Land Surveyor, dated May 5, 2008, is hereby approved.


