

RESOLUTION R-61-08


A RESOLUTION APPROVING YOUNGBERG'S PLAT OF CONSOLIDATION (303 & 313 E. Prairie Avenue)



TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN,
ACCORDING TO THE PLAT THEREOF RECORDED SEPTEMBER 24, 1962 AS
DOCUMENT R62-33744, IN DUPAGE COUNTY, ILLINOIS; AND

THAT PART OF THE EAST HALF OF THE SOUTHWEST QUARTER OF SECTION 9,
TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN
DESCRIBED AS FOLLOWS: COMMENCING AT THE CENTER OF MAIN STREET AND
HARRISON AVENUE IN THE CITY OF WHEATON (SAID POINT BEING THE
SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF THE SOUTHWEST
QUARTER OF SAID SECTION) THENCE NORTH ALONG THE CENTER OF MAIN
STREET, 1254.0 FEET TO THE NORTH LINE OF PRAIRIE AVENUE; THENCE EAST
ALONG THE NORTH LINE OF PRAIRIE AVENUE, 939.9 FEET FOR A PLACE OF
BEGINNING; THENCE NORTH PARALLEL WITH SAID MAIN STREET, 378.0 FEET;
THENCE EAST PARALLEL WITH SAID PRAIRIE AVENUE, 152.3 FEET; THENCE
SOUTH PARALLEL WITH SAID MAIN STREET, 378.0 FEET TO THE NORTH LINE OF
SAID PRAIRIE AVENUE; THENCE WEST ALONG THE SAID NORTH LINE, 152.3 FEET
TO THE PLACE OF BEGINNING, IN DUPAGE COUNTY, ILLINOIS.
