
A RESOLUTION APPROVING ANDERSON PLAT OF CONSOLIDATION (Wheaton College)

WHEREAS, Wheaton College has submitted a plat of consolidation of the properties located in the block bordered by Howard Street, College Avenue, and the vacated rights-of-way of Chase Street and University Place to the City for approval (the property is described on Exhibit "A" attached to this resolution); and the Wheaton City staff has recommended that the plat of consolidation be approved.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois that the plat of Anderson Plat of Consolidation, as prepared by Daniel Sytsma, an Illinois Professional Land Surveyor, dated October 14, 2008 is hereby approved.


