

## RESOLUTION R-19-13

### A RESOLUTION FOR THE IMPROVEMENT BY MUNICIPALITY UNDER THE ILLINOIS HIGHWAY CODE


**BE IT RESOLVED**, by the Mayor and City Council of the City of Wheaton, Illinois that the following described streets be improved under the Illinois Highway Code: (street listing attached as Exhibit A).

**BE IT FURTHER RESOLVED**,

1. That the proposed improvement shall consist of approximately 123,323 SY of pavement overlay including pavement milling, leveling binder, area reflective crack control treatment, and surface course; 2,730 SY of pavement reconstruction including pavement and base removal, aggregate and HMA base reconstruction, leveling binder, area reflective crack control treatment, and surface course; curb & gutter drive approach and sidewalk removal and replacement; storm & sanitary sewer structure replacement; water main replacement; water service replacement; and landscaping along various streets in the City of Wheaton; and shall be designated as Section 13-00108-00-FP.
2. That there is hereby appropriated the sum of ONE MILLION FOUR HUNDRED SEVENTY-FIVE THOUSAND dollars (\$1,475,000.00) for the improvement of said section from the municipality's allotment of Motor Fuel Tax funds.
3. That the work shall be done by contract; and,

**BE IT FURTHER RESOLVED**, that the City Clerk is hereby directed to transmit two certified copies of this resolution to the district office of the Department of Transportation.
