**A RESOLUTION ACCEPTING TRANSFER OF CERTAIN PRIVATE UTILITIES
WITHIN MAIN STREET MARKETPLACE TO THE CITY OF WHEATON AND
APPROVING A GRANT OF EASEMENT FOR MAINTENANCE PURPOSES OF THE
PRIVATE UTILITIES**


WHEREAS, the owner of Main Street Marketplace located at the northwest corner of Geneva Road and Main Street, 336 N Michigan Avenue Partnership, has submitted a formal request to transfer the ownership and maintenance of the private water main within the property to the City (the property is legally described in Exhibit A, attached to this resolution); and

WHEREAS, the owner has met the requirements of Section 74-70 of the Wheaton City Code in order to transfer to the City ownership and maintenance of the private water main within the property.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and City Council of the City of Wheaton, Illinois, that the City Council accepts transfer of the private water main within Main Street Marketplace and that the City Council approves the Grant of Easement for maintenance of the water main, prepared by Raymond R. Hansen, an Illinois professional land surveyor, dated May 10, 2013.

IT IS FURTHER RESOLVED that the Mayor is authorized to sign the approval form and the City Clerk is authorized and directed to attest to the signature of the Mayor and attach a certified copy of this resolution of acceptance to the Grant of Easement.

Domestic and private services lines serving the buildings served by said existing watermain shall remain the private personal property of the owner served.

The Seller hereby covenants that it is the owner of the afore-described goods, chattels and personality; that such items are free from all liens, charges and encumbrances; that the Seller has the right, power and authority to sell the same as aforesaid; and that the Seller warrants and will defend the same against the lawful claims and Demands of all persons; and that the execution of this Bill of Sale is an authorized act of said corporation, individual, partnership or limited liability company.




