
A RESOLUTION APPROVING A  
PLAT OF STORMWATER MANAGEMENT EASEMENT GRANT  
(1356 North Gary Avenue)

**WHEREAS**, the owner of the property located at 1356 North Gary Avenue has presented a plat of easement grant for stormwater management to the City for approval (the property is legally described in Exhibit A, attached to this resolution); and the Wheaton City staff has recommended that the easement grant be approved.


