

## RESOLUTION R-14-16

### RESOLUTION AUTHORIZING THE EXECUTION OF AN AMENDMENT TO A CERTAIN TEMPORARY LICENSE AGREEMENT

WHEREAS, Commonwealth Edison Company ("ComEd") owns certain real property commonly known as the ("Subject Premises") located in the SW quarter of Section 16, Township 39 North, Range 10 East of the third principal falling within the Commonwealth Edison right-of-way, in DuPage County, Illinois, and

WHEREAS, ComEd and the City of Wheaton ("The City") desired to enter into an agreement for the purposes of granting The City a license to access and use the Subject Premises, and

WHEREAS, On November 2, 2015, the Mayor and City Council approved R-68-15, which authorized the execution of a certain temporary license agreement which shall expire on April 30, 2016, and

WHEREAS, ComEd and Licensee desire to extend said temporary license agreement for an additional nine (9) month period, terminating on January 31, 2017.



## AMENDMENT TO TEMPORARY LICENSE AGREEMENT

This Amendment to Temporary License Agreement (this "**Amendment**") is made April 18, 2016, by and between COMMONWEALTH EDISON COMPANY, an Illinois corporation ("Licensor"), and THE CITY OF WHEATON ("Licensee")

### RECITALS

- A. Pursuant to that certain Temporary License Agreement (the "**License**") dated August 1, 2015, Licensor granted a license to Licensee to the Licensed Premises located in DuPage County, Illinois, as further described therein.
- B. By its terms, the License will expire on April 30, 2016. Licensee desires and Licensor hereby agrees to extend the term of the License pursuant to the terms and conditions herein.
- C. Licensor and Licensee desire to amend the License as set forth herein.

NOW, THEREFORE, for and in consideration of the recitals set forth above, which are incorporated herein and made a part hereof, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, agree that the Lease is hereby amended and modified as follows:

#### 1. TERM:

The Term of the License is hereby extended for an additional nine (9) month period, terminating on January 31, 2017.

#### 2. LICENSE FEE:

Concurrently with the execution and delivery by Licensee of this Amendment, Licensee shall pay to Licensor the License Fee in the amount of \$2,145.00 in lawful money of the United States.

#### 3. FULL FORCE AND EFFECT:

Except as expressly modified in this Amendment, all of the terms and conditions of the License shall remain in full force and effect, the parties hereto ratifying and confirming the same.

#### 4. COUNTERPARTS:




