
**WHEREAS**, the City has a continued need for line striping-thermoplastic; and

AMENDMENT #1 OF AGREEMENT #C 36859

Agreement between the CITY of WHEATON, ILLINOIS  
And SUPERIOR ROAD STRIPING, INC.,  
for LINE STRIPING - THERMOPLASTIC

This Amendment is entered into as of this 5<sup>th</sup> day of June 2017 by and between the CITY OF WHEATON, an Illinois municipal corporation ("City"), 303 West Wesley Street, Wheaton, IL 60187, and SUPERIOR ROAD STRIPING, INC., ("Contractor"), 1980 N. Hawthorne Avenue, Melrose Park, IL 60160.

**WHEREAS**, the City and the Contractor entered into an Agreement (City Agreement #C 36859-Exhibit A) dated April 18, 2016 to provide line striping-thermoplastic; and

**WHEREAS**, the City has a continued need for line striping-thermoplastic; and



2. All other provisions of the Agreement, except as modified herein, are hereby ratified and reaffirmed.
