AN ORDINANCE AMENDING THE 1995 TAX LEVY CONTAINED  
IN ORDINANCE NO. E-4155 AND AMENDED IN ORDINANCE  
NO. E-4156 AND ORDINANCE NO. E-4157

WHEREAS, the City Council of the City of Wheaton passed an Ordinance No. E-4155 levying taxes for corporate purposes and debt service for the fiscal year commencing May 1, 1995 and ending April 30, 1996, for the City of Wheaton; and

WHEREAS, said ordinance has been filed with the County Clerk of DuPage County in accordance with the applicable state statutes; and

WHEREAS, the City of Wheaton has exercised its home rule powers in adopting Ordinance No. E-1279 establishing a general corporate tax levy for the City of Wheaton in lieu of separate levies; and

WHEREAS, the City of Wheaton desires to further amend Ordinance No. E-4155.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois:

Section 1. That the County Clerk of the County of DuPage is hereby authorized and directed to amend the taxes hitherto provided for and levied in Ordinance No. E-4155 so as to reduce the amount heretofore levied.

Section 2. That the bond and interest levy of \$2,596,708 established in Ordinance No. E-4155 and abated by \$227,862.50 to \$2,149,887.50 in Ordinance No. E-4156 be further abated as follows:

1. That the amount levied in Ordinance No. E-3371 of \$501,350 be abated by \$4,964 to \$496,386.
2. That the amount levied in Ordinance No. E-3698 of \$489,000 be abated by \$4,841 to \$484,159.
3. That the amount levied in Ordinance No. E-3837 of \$1,159,237.50 be abated by \$11,477.50 to \$1,147,760.

The resulting total levy for debt service shall be \$2,128,305.

Section 3. That the original general corporate levy of \$6,386,892 established in Ordinance No. E-4155, and abated by \$156,479 to \$6,230,413 in Ordinance No. E-4157 be further abated by \$196,945 to \$6,033,468.

Section 4. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 5. That the City Clerk is hereby ordered and directed to cause a certified copy of this ordinance to be filed with the County Clerk of DuPage County.

Section 6. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, in the manner prescribed by law.
