

ORDINANCE NO. F-0033

AN ORDINANCE GRANTING A FRONT YARD VARIATION ON A CERTAIN PIECE OF PROPERTY COMMONLY KNOWN AS 324 W. PRAIRIE AVENUE - BOMHER

WHEREAS, written application has been made requesting a variation from the provisions of the City of Wheaton Zoning Ordinance in order to construct an attached garage on a certain piece of property legally described herein and commonly known as 324 W. Prairie Avenue, Wheaton, Illinois; and

WHEREAS, pursuant to notice as required by the Illinois Municipal Code and the Wheaton Zoning Ordinance, a public hearing was conducted by the Wheaton Board of Zoning Appeals on April 23, 1996, to consider the variation request and the Wheaton Board of Zoning Appeals has unanimously recommended approval of the zoning variation.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, DuPage County, Illinois, pursuant to its home rule powers, as follows:

Section 1: Pursuant to the Findings of Fact determined by the Wheaton Board of Zoning Appeals, a variation from the requirements of the Wheaton Zoning Ordinance is granted to permit a decrease in the front yard setback from 30 feet to 28 feet in order to construct an attached garage in substantial compliance with the plans entitled "*Bomher Garage Addition*" prepared by Waterman Brothers Construction, Inc., dated March, 1996.

The property that is subject of the variation is legally described as:

LOT 3 AND THE WEST 10 FEET OF LOT 2 IN BLOCK 5 IN RESUBDIVISION OF BLOCKS 3, 4, AND 5 OF JESSE C. WHEATON, JR.'S ADDITION TO WHEATON, A SUBDIVISION IN SECTIONS 8 AND 9, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT OF SAID RESUBDIVISION RECORDED NOVEMBER 6, 1911, AS DOCUMENT 106046 IN DUPAGE COUNTY, ILLINOIS.

The property is commonly known as 324 W. Prairie Avenue, Wheaton, Illinois 60187.

Section 2: All ordinances or parts of ordinances in conflict with these provisions are repealed.

Section 3: This ordinance shall become effective from and after its passage, approval, and publication in pamphlet form in the manner prescribed by law.
