

ORDINANCE NO. F-0086

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF  
TAXES FOR THE FISCAL YEAR BEGINNING MAY 1, 1996  
AND ENDING APRIL 30, 1997, IN AND FOR  
THE CITY OF WHEATON SPECIAL SERVICE AREA NUMBER FOUR

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois,  
as follows:

Section 1: Findings. The City of Wheaton Special Service Area Number Four has been created by an ordinance entitled, "An Ordinance Establishing City of Wheaton Special Service Area Number Four", adopted December 21, 1992, and effective as of December 22, 1992, no valid petition having been filed opposing the creation of the special service area, pursuant to the Special Service Area Tax Act. Special Service Area Number Four consists of the territory described in the ordinance aforesaid. The City of Wheaton is authorized to levy taxes for special services in Special Service Area Number Four.

Section 2: The total amount of appropriations for all the purposes to be collected from the tax levy of the current fiscal year in Special Service Area Number Four is ascertained to be the sum of \$107,400.

Section 3: The following sums shall be levied upon the taxable property as defined in the Revenue Act of 1939, in the City of Wheaton Special Service Area Number Four; said tax to be levied for the fiscal year beginning May 1, 1996, and ending April 30, 1997.

Section 4: This tax is levied pursuant to Article VII, Section 6A and 6L, of the Constitution of the State of Illinois pursuant to Public Act 78-901 and pursuant to An Ordinance Establishing City of Wheaton Special Service Area Number Four.


Section 5: The \$107,400 tax levy is certified to the County Clerk of DuPage County, Illinois. The City of Wheaton determines this \$107,400 tax levy to be the total amount required to be raised by taxation for the current fiscal year of the City for Special Service Area Number Four. The City Clerk of Wheaton, Illinois, is ordered and directed to file with the County Clerk of DuPage County, on or before the time required by law, a certified copy of this ordinance.

Section 6: All ordinances or parts or ordinances in conflict with these provisions are repealed.

Section 7: This ordinance shall become effective from or after its passage, approval, and publication in the manner prescribed by law.
