**AN ORDINANCE AMENDING THE 1996-97 BUDGET  
CONTAINED IN ORDINANCE NO. F-0024**

WHEREAS, the City of Wheaton has heretofore adopted the Illinois Municipal Budget Law as set out in 50 ILSC 330/1 through 330/5 (1994 State Bar Edition), and

WHEREAS, the City Council of the City of Wheaton has passed an ordinance No. F-0024 adopting the annual budget of the City of Wheaton for the fiscal year commencing May 1, 1996 and

WHEREAS, said ordinance was filed with the County Clerk of DuPage County in accordance with the applicable State statutes, and

WHEREAS, the City Council desires to amend the budget contained in Ordinance No. F-0024; and

WHEREAS, sufficient funds are available to amend the budget for the fiscal year commencing May 1, 1996,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, Illinois:

Section 1. That the budget of the 1991 G.O. Bond Fund be established in the amount of \$135,000 in order to create the following budgets:

Section 2. That the budget of the 1996 G.O. Bond Fund be established in the amount of \$135,000 in order to create the following budget:

Section 3. That the budget of the Parking Meter Revenue Fund be increased in the amount of \$900,000 in order to create the following budgets:


Section 6. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
