ORDINANCE NO. F-0205

**AN ORDINANCE AMENDING THE 1997 TAX LEVY
CONTAINED IN ORDINANCE NO. F-0204**

WHEREAS, the City Council of the City of Wheaton passed an Ordinance No. F-0204 levying taxes for corporate purposes for the fiscal year commencing May 1, 1997 and ending April 30, 1998, for the City of Wheaton; and

WHEREAS, said ordinance has been filed with the County Clerk of DuPage County in accordance with the applicable state statutes; and

WHEREAS, the City of Wheaton has exercised its home rule powers in adopting Ordinance No. E-1279 establishing a general corporate tax levy for the City of Wheaton in lieu of separate levies; and

WHEREAS, the City of Wheaton desires to amend Ordinance No. F-0204.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, Illinois:

Section 1. That the County Clerk of the County of DuPage is hereby authorized and directed to amend the taxes hitherto provided for and levied in Ordinance No. F-0204 so as to reduce the amount heretofore levied.

Section 2. That the bond and interest levy of \$3,301,850 established in Ordinance No. F- be abated as follows:


1. That the amount levied in Ordinance No. E-3690 of \$331,187 be abated by \$184,000 to \$147,188.
2. That the amount levied in Ordinance No. E-3928 of \$229,988 be abated by \$229,988 to \$0.
3. That the amount levied in Ordinance No. E-4078 of \$28,125 be abated by \$28,125 to \$0.
4. That the amount levied in Ordinance No. E-4079 of \$236,700 be abated by \$236,700 to \$0.
5. That the amount levied in Ordinance No. F-0190 of \$264,500 be abated by \$1,829 to \$262,671.

The resulting total levy for bond and interest shall be \$2,621,209.

Section 3. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 4. That the City Clerk is hereby ordered and directed to cause a certified copy of this ordinance to be filed with the County Clerk of DuPage County.


Section 5. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, in the manner provided by law.
