

ORDINANCE NO. F-0215

AN ORDINANCE AUTHORIZING A WATER AND SEWER RATE CHANGE
FOR THE CITY OF WHEATON, DUPAGE COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

SECTION 1: That paragraphs (2) and (3) of Section 74-316 (Rates for water and/or sewer service) of the Wheaton City Code, 1996, as amended, are hereby further amended to read as follows:

(2) Water service only within corporate limits.

For each user of the combined system using water service only within the corporate limits, the monthly charge shall be \$2.20 for 100 cubic feet. The minimum charge for water service only shall be \$2.20 per month.

(3) Sewer service only within corporate limits.

For unmetered sewer service only within the corporate limits, there shall be a flat charge of \$31.75 per quarter period. Any user served by the sewerage system only of the City may install, or the City may require any user to install, a city meter to measure the amount of private water supply entering such sewage system. Such meter shall be subject to the same regulations and control as all municipally owned water supplies. When private water is metered, the rate for sewer only shall be \$1.10 per 100 cubic feet. The minimum quarterly charge for such metered sewer used shall be \$5.00 per quarter period.

Subparagraphs (1), (4), (5) and (6) of Section 74-316 shall remain in full force and effect.

SECTION 2: That paragraph (13) of Section B-22 of Appendix B (Fee Schedule) of the Wheaton City Code, 1996, as amended, is hereby further amended to read as follows:

(13) Individual rates for water and sewer service within the corporate limits (noncombined) system:

| (c) | Nonmetered sewer service only within the corporate limits (flat charge, per quarter) | \$31.75 |

- (d) Any user serviced by the sewage system only of the City may install or the City may require any user to install a City meter to measure the amount of private water supply entering the sewage system. Said meter shall be subject to the same regulations and control as meters used for the municipally owned water system.

1. Private metered water use per 100 cubic feet, per quarter \$ 1.10
2. Minimum charge per quarterly period \$ 5.00


SECTION 3: All ordinances or parts of ordinances in conflict with these provisions are repealed.

SECTION 4: This ordinance shall be effective following passage, approval and publication in pamphlet form in the manner prescribed by law for bills issued after February 28, 1998.
