AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF
TAXES FOR THE FISCAL YEAR BEGINNING MAY 1, 1999
AND ENDING APRIL 30, 2000 IN AND FOR
THE CITY OF WHEATON SPECIAL SERVICE AREA NUMBER TWO

BE IT ORDAINED BY THE Mayor and City Council of the City of Wheaton, Illinois,
pursuant to its home rule powers, as follows:

Section 1: Findings. The City of Wheaton Special Service Area Number Two has been created by an ordinance entitled, "An Ordinance Establishing City of Wheaton Special Service Area Number Two", adopted February 8, 1983, and effective as of February 9, 1983, no petition having been filed opposing the creation of the special service area, pursuant to Public Act 88-455. Special Service Area Number Two consists of the territory described in the ordinance aforesaid. The City of Wheaton is authorized to levy taxes for special services in Special Service Area Number Two.

Section 2: The total amount of appropriations for all the purposes to be collected from the tax levy of the current fiscal year in Special Service Area Number Two is ascertained to be the sum of \$40,087.

Section 3: The following sums shall be levied upon the taxable property as defined in Public Act 88-455, in the City of Wheaton Special Service Area Number Two; said tax to be levied for the fiscal year beginning May 1, 1999, and ending April 30, 2000.

Section 4: This tax is levied pursuant to Public Act 88-455 and pursuant to An Ordinance Establishing City of Wheaton Special Service Area Number Two.


Section 5: The \$40,087 tax levy is certified to the County Clerk of DuPage County, Illinois. The City of Wheaton determines this \$40,087 tax levy to be the total amount required to be raised by taxation for the current fiscal year of the City for Special Service Area Number Two. The City Clerk of Wheaton, Illinois, is ordered and directed to file with the County Clerk of DuPage County, on or before the time required by law, a certified copy of this ordinance.

Section 6: All ordinances or parts or ordinances in conflict with these provisions are repealed.

Section 7: This ordinance shall become effective from and after its passage, approval, and publication in the manner prescribed by law.
