

ORDINANCE NO. F-0433

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR
VEHICLE AND TRAFFIC SCHEDULES (CHAPTER 70)
FOR THE CITY OF WHEATON, ILLINOIS
(SCHOOL SPEED ZONES)**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

SECTION 1: That the Official Motor Vehicle and Traffic Schedule II. (Streets designated as school zones) as referred in Section 70-261 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

Jewel Road from 200 feet east of the Sandburg School property line to 200 feet west of the Sandburg School property line.

Manchester Road from 200 feet east of the Monroe Junior High School property line to 200 feet west of the Monroe Junior High School property line.

Orchard Road from 200 feet south of Durfee Road to 200 feet north of Durfee Road.

President Street from 200 feet south of Bridle Lane to 200 feet north of Bridle Lane.

Roosevelt Road from 200 feet east of the St. Francis High School property line to 200 feet west of the St. Francis High School property line.

Santa Rosa Avenue from 200 feet south of Cadillac Drive.

SECTION 2: That the Official Motor Vehicle and Traffic Schedule XIV. (Certain turns prohibited at certain intersections) as referred in Section 70-211 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

(a) Prohibited right turns on steady red signal:

(3) All directions at Roosevelt Road and Naperville Road (on school days when children are present).


SECTION 3: That the Official Motor Vehicle and Traffic Schedule VI. (Parking prohibited at all times on certain streets) as referred in Section 70-354(c) of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

(64) Cole Avenue - north side - from Main Street to Papworth Street; south side - from Papworth Street to approximately 525 feet east thereof, and Main Street to 300 feet west thereof.

SECTION 4: That all ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.

SECTION 5: That this ordinance shall become effective from and after its passage approval and publication in a manner provided by law.
