

**ORDINANCE NO. F-0444**

**AN ORDINANCE AMENDING CHAPTER 70, "TRAFFIC AND VEHICLES,"  
OF THE WHEATON CITY CODE,  
ARTICLE IV, "STOPPING, STANDING AND PARKING,"  
"SECTION 70-415, APPLICATION FOR PARKING AUTHORIZATION."**

**WHEREAS**, the City of Wheaton, Illinois ("City"), is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and, as such, the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the subject matter of this ordinance pertains to the government and affairs of the City and its residents; and

**WHEREAS**, the City has determined it to be in the best interests of the City and its residents to amend the provisions of the City Code pertaining to the application for parking authorization.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Wheaton, DuPage County, Illinois, pursuant to its home rule powers, as follows:

Section 1: Section 70-415 of Chapter 70 of the Wheaton City Code is amended by repealing and rescinding Section 70-415 in its entirety and replacing it with a new Section 70-415 of Chapter 70 of the Wheaton City Code, which shall read as follows:

"Sec. 70-415. Application for parking authorization.

(a) Application for leased parking authorization as provided in schedule X-D shall be made in writing upon forms furnished by the City Clerk. Upon payment of the fee provided thereof, the City Clerk shall issue or cause to be issued a parking authorization, which shall be attested by the City Clerk, for use of such leased space. The City Clerk or other authorized designee shall issue or cause to be issued a transponder to those approved applicants for leased parking for Central Business District Lot No. 1, upon payment of a \$25.00 deposit. Such deposit shall be refunded to the applicant within 25 days of the date the transponder is returned to the City Clerk or other authorized designee.

(b) The City Clerk shall refuse to consider any application for leased parking authorization from any person who has one or more unpaid City of Wheaton parking ticket(s). In such instance, the City Clerk or other authorized designee shall return the application to the applicant with a letter informing the applicant of the basis for the refusal of the application.

(c) The City Clerk or other authorized designee shall not issue, cause to be issued or renew a leased parking authorization to any person who has one or more unpaid City of Wheaton parking tickets. In such instance, the City Clerk or other authorized designee shall return the renewal application to the applicant with a letter informing the applicant of the basis for the refusal of the renewal application. The City Clerk or other authorized designee shall deactivate the transponder previously provided to any person who was issued a leased parking authorization but whose leased parking authorization will not be renewed because the person has one or more unpaid City of Wheaton parking tickets.

(d) When reviewing an application for parking authorization, the City Clerk or other authorized designee has the authority and is directed to examine City parking ticket records to determine whether the applicant has any unpaid City parking tickets.”


Section 2: In all other respects, the terms and provisions of the Wheaton City Code, as amended, are ratified and remain in full force and effect.

Section 3: All ordinance or parts of ordinances in conflict with these provisions are repealed.

Section 4: This ordinance shall become effective from and after its passage, approval, and publication in pamphlet form in the manner prescribed by law.
