

**ORDINANCE NO. F-0499**

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR  
VEHICLE AND TRAFFIC SCHEDULES (CHAPTER 70)  
FOR THE CITY OF WHEATON, ILLINOIS  
(PARKING)**

**BE IT ORDAINED** by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1: That Section 70-354(i) of the Wheaton City Code, 1996, as amended, is hereby deleted in its entirety and replaced as follows:

- (i) *Central business district municipal parking lots 1 and 2.* No person shall park a vehicle in any space within central business district parking lots no. 1 (Municipal Parking Structure, south side of Wesley between Hale Street and Wheaton Avenue) and no. 2 (south side of Wesley between Main Street and Hale Street) for more than the time limits as posted between the hours of 8:00 a.m. and 6:00 p.m., nor shall they move from space to space within the designated lot in order to extend the parking time limits for their use, Monday through Saturday, holidays excepted.

Section 2: That the Official Motor Vehicle and Traffic Schedule VIII (Parking Time Limited) as referred in Section 70-354(f) of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

**II Off-Street Limited Parking Time:**

- (a) *4-hour limit:*
  - (1) Reserved
- (b) *3-hour limit:*
  - (1) Parking Lot #2
  - (2) Parking Lot #1 (Municipal Parking Structure) Level 2
  - (3) Parking Lot #1 (Municipal Parking Structure) Level 1
- (c) *2-hour limit:*
  - (1) Reserved

Section 3: That the Official Motor Vehicle and Traffic Schedule X-A (Metered Parking - On Street) as referred in Section 70-382 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

- (b) *9-hour limit:*
  - (1) Reserved

Section 4: That the Official Motor Vehicle and Traffic Schedule X-C (Metered Parking - Off Street) as referred in Section 70-382 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

(1) Reserved.

Section 5: That the Official Motor Vehicle and Traffic Schedule X-D (Leased Parking) as referred in Section 70-413 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

(7) Municipal Parking Structure (at Wheaton Avenue between Wesley and Front); leased parking Monday-Friday; Twenty-five dollars (\$25.00) per month.


(8) Reserved.

Section 6: That all Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.
