

ORDINANCE NO. F-0534

**AN ORDINANCE AMENDING ARTICLE 2, SECTION 2-32
OF THE WHEATON CITY CODE (COMPENSATION)**

WHEREAS, 65 ILCS 5/3.1-50-10 provides that any salary for an elected Municipal Officer be fixed for a definite term by Ordinance; and

WHEREAS, the elected Council Members of the City of Wheaton devote significant time, study, work and energy to fulfil the duties and responsibility of their elective office; and

WHEREAS, the Corporate Authorities of the City of Wheaton have determined that the provision of compensation to Council Members will encourage participation in City Government; and

WHEREAS, based upon the effective date of this Ordinance none of the current Council Members of the City of Wheaton will not derive any compensation from this Ordinance prior to expiration of their current term.

NOW THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, DuPage, Illinois, that Section 2-32 entitled "Compensation" of Article 2 of the Wheaton City Code is hereby repealed and rescinded in it's entirety and replaced with a new section 2-32 which shall read as follows:

Section 1 - Section 2-32 "Compensation of City Council"

- a) City Council Members shall receive monetary compensation as follows:
 - 1. Annual Compensation of \$3,000.00 to be paid by the City to the Council Member on a quarterly basis of each annual fiscal year the Council serves.
 - 2. The City shall further provide \$25,000.00 of term life insurance coverage, convertible to whole life at term, for each Council Member. In addition to life insurance coverage, the Council Member should

have the option of participating in the City's group hospitalization and major medical insurance program. Any elected official who chooses to participate in the City's hospitalization and major medical insurance program and selects dependant coverage shall reimburse the City for the cost of the dependant's coverage portion of the premium.

- b) The compensation provided for in paragraph "a" "1" of this Ordinance shall commence in May of 2003, as to all Council Members then serving.
- c) The compensation provided for in subsection "a" "2" of this Ordinance shall remain in full force and effect as it existed on the date of the passage of this Ordinance.

Section 2: All ordinances and parts of ordinances in conflict with or inconsistent with the provisions of this ordinance are hereby repealed to the extent of any such conflict or inconsistency.

Section 3: That if any part or portion of this ordinance shall be declared invalid by a court of competent jurisdiction, such invalidity shall not affect the remainder of this ordinance.

Section 4: This ordinance shall become effective after its passage, approval and publication in pamphlet form in the manner described by law.
