

ORDINANCE NO. F-0536

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR
VEHICLE AND TRAFFIC SCHEDULES (CHAPTER 70)
FOR THE CITY OF WHEATON, ILLINOIS**

**(4-HOUR PARKING)
(NO TURN ON RED)
(SCHOOL SPEED ZONE)
(YIELD)**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

SECTION 1: That the Official Motor Vehicle and Traffic Schedule VIII. (Parking time (nonmetered) limited on certain streets and off-street lots) as referred in Section 70-354(f) of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

III. On-Street Parking Time:

(a) 4-hour limit:

(11) Jefferson Avenue

Both sides from Wheaton Avenue to Gary Avenue.

SECTION 2: That the Official Motor Vehicle and Traffic Schedule XIV. (Certain turns prohibited at certain intersections) as referred in Section 70-211 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

(a) Prohibited right turns on steady red signal:

(4) All directions at West Street and Illinois/Childs Street(s) (on school days when children are present).

SECTION 3: That the Official Motor Vehicle and Traffic Schedule II. (Streets designated as school zones) as referred in Section 70-261 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

(Delete) President Street from Willow Avenue to 200 feet south of Illinois Street.


President Street from 200 feet south of Willow Avenue to 200 feet south of Illinois Street.

SECTION 4: That the Official Motor Vehicle and Traffic Schedule V. (Yield right-of-way intersections) as referred in Section 70-307 of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:

(17) All traffic on Coolidge Avenue shall yield the right-of-way to traffic on Prospect Street.

SECTION 5: That all ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.

SECTION 6: That this ordinance shall become effective from and after its passage approval and publication in a manner provided by law.
