ORDINANCE NO. F-0767

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE II, OF THE WHEATON CITY CODE – “CITY ELECTION DISTRICTS”

WHEREAS, the results of the 2000 Census and the Constitution of the United States mandate amendment to the City of Wheaton election districts.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, DuPage County, Illinois, pursuant to its home rule powers, as follows:

Section 1: The Wheaton City Code, 1996, as amended, is hereby further amended by deleting Section 2-31, “Composition; election; term of office commencing in 1993”, thereof in its entirety and adding and including, in lieu thereof, the following:

“Sec. 2-31. Composition; election; term of office; amended election districts.

(a) The city shall be divided into four city council election districts; and the membership of the city council shall be six members, with one councilmember being elected from each district commencing in 1993 and thereafter, for a term of four years and the mayor and two councilmembers being elected at large commencing in 1995 and thereafter, each for a term of four years.

(b) At the election of councilmembers from districts, each elector shall vote for one councilmember from the elector’s respective district at the primary election, if any, and the general election. With the election of councilmembers at large, two councilmembers shall be voted for by each elector at the primary election, if any, and the general election. At the election of the mayor, one candidate for mayor shall be voted for by each elector at the primary election, if any, and the general election.

(c) The mayor and councilmembers shall take office at the first regular or special meeting in the month following their election.

(d) The city council election districts shall be designated as the North, South, East and West City Council Election Districts, respectively. Commencing with the 2005 primary election, if any, and the 2005 general election, the four city council amended election districts shall be comprised of the geographic locations legally described as follows:

CITY OF WHEATON ELECTION DISTRICTS

(In Townships 39 North, Ranges 9 and 10 East of the

NORTH CITY COUNCIL ELECTION DISTRICT

ALL OF THAT PART OF THE CITY OF WHEATON, AS INCORPORATED ON OCTOBER 7, 2002, LYING NORTHERLY OF THE FOLLOWING DESCRIBED LINE: BEGINNING AT THE INTERSECTION OF THE EASTERLY BOUNDARY LINE OF THE CITY OF WHEATON WITH THE CENTERLINE OF THE UNION PACIFIC RAILROAD RIGHT-OF-WAY (FORMERLY CHICAGO & NORTHWESTERN RAILROAD RIGHT-OF-WAY), THENCE WESTERLY ALONG THE CENTERLINE OF SAID UNION PACIFIC RAILROAD RIGHT-OF-WAY TO ITS INTERSECTION WITH THE WESTERLY CITY BOUNDARY, BEING THE WESTERLY LINE OF MILTON TOWNSHIP WITH SAID UNION PACIFIC RAILROAD RIGHT-OF-WAY.

EAST CITY COUNCIL ELECTION DISTRICT

ALL OF THAT PART OF THE CITY OF WHEATON, AS INCORPORATED ON OCTOBER 7, 2002, LYING SOUTHERLY OF THE CENTERLINE OF THE UNION PACIFIC RAILROAD RIGHT-OF-WAY (FORMERLY CHICAGO & NORTHWESTERN RAILROAD RIGHT-OF-WAY) AND LYING NORTHERLY AND EASTERLY OF A LINE DESCRIBED AS FOLLOWS: BEGINNING AT THE INTERSECTION OF SUMNER STREET WITH THE CENTERLINE OF SAID UNION PACIFIC RAILROAD RIGHT-OF-WAY, THENCE SOUTHERLY ALONG THE CENTERLINE OF SUMNER STREET TO THE CENTERLINE OF LIBERTY DRIVE, THENCE WESTERLY ALONG THE CENTERLINE OF LIBERTY DRIVE TO THE CENTERLINE OF NAPERVILLE ROAD, THENCE SOUTHERLY ALONG THE CENTERLINE OF NAPERVILLE ROAD TO THE CENTERLINE OF ILLINOIS STREET, THENCE EASTERLY ALONG THE CENTERLINE OF ILLINOIS STREET TO THE CENTERLINE OF WASHINGTON STREET, THENCE SOUTHERLY ALONG THE CENTERLINE OF WASHINGTON STREET TO THE CENTERLINE OF INDIANA STREET, THENCE WESTERLY ALONG THE CENTERLINE OF INDIANA STREET TO THE CENTERLINE OF NAPERVILLE ROAD, THENCE SOUTHERLY ALONG THE CENTERLINE OF NAPERVILLE ROAD TO THE CENTERLINE OF ROOSEVELT ROAD (ILLINOIS ROUTE 38), THENCE WESTERLY ALONG THE CENTERLINE OF ROOSEVELT ROAD TO THE CENTERLINE OF WEST STREET/WARRENVILLE ROAD, THENCE SOUTHERLY ALONG THE CENTERLINE OF WARRENVILLE ROAD TO THE CENTERLINE OF ELM STREET, THENCE EASTERLY ALONG THE CENTERLINE OF ELM STREET TO THE CENTERLINE OF NAPERVILLE ROAD, THENCE SOUTHERLY ALONG THE CENTERLINE OF NAPERVILLE ROAD TO THE CENTERLINE OF TENNYSON DRIVE, THENCE EASTERLY ALONG THE CENTERLINE OF TENNYSON DRIVE TO THE CENTERLINE OF HAVERHILL DRIVE, THENCE NORTHERLY ALONG THE CENTERLINE OF HAVERHILL DRIVE TO THE CENTERLINE OF FARNHAM LANE, THENCE EASTERLY ALONG THE CENTERLINE OF FARNHAM LANE TO THE CENTERLINE OF PRESIDENT STREET, THENCE SOUTHERLY ALONG THE CENTERLINE OF PRESIDENT STREET TO THE CENTERLINE OF BLANCHARD STREET, THENCE SOUTHERLY ALONG THE CENTERLINE OF BLANCHARD STREET TO THE EXTENSION OF THE SOUTHERLY LINE OF CASA SOLANA SUBDIVISION, A SUBDIVISION IN SECTIONS 27 AND 28 OF SAID TOWNSHIP 39 NORTH, RANGE 10

EAST OF THE THIRD PRINCIPAL MERIDIAN, THENCE EASTERLY ALONG THE SOUTHLINE OF SAID CASA SOLANA SUBDIVISION AND THE EXTENSION THEREOF TO THE CENTERLINE OF BRIARCLIFFE BOULEVARD, THENCE SOUTHERLY ALONG THE CENTERLINE OF BRIARCLIFFE BOULEVARD TO THE NORTHERLY LINE OF BRIARCLIFFE UNIT NO. 1 SUBDIVISION, A SUBDIVISION IN THE SOUTHWEST QUARTER OF SECTION 27, IN SAID TOWNSHIP 39 NORTH, K RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, THENCE EASTERLY ALONG THE NORTHERLY LINE OF SAID BRIARCLIFFE UNIT NO. 1 SUBDIVISION, TO THE EXISTING CORPORATE LIMITS OF THE CITY OF WHEATON.

WEST CITY COUNCIL ELECTION DISTRICT

ALL OF THAT PART OF THE CITY OF WHEATON, AS INCORPORATED ON OCTOBER 7, 2002, LYING SOUTHERLY OF THE CENTERLINE OF THE UNION PACIFIC RAILROAD RIGHT-OF-WAY (FORMERLY CHICAGO & NORTHWESTERN RAILROAD RIGHT-OF-WAY), AND LYING WESTERLY AND NORTHERLY OF A LINE DESCRIBED AS FOLLOWS: BEGINNING AT THE INTERSECTION OF THE CENTERLINE OF SAID UNION PACIFIC RAILROAD RIGHT-OF-WAY WITH THE CENTERLINE OF SUMNER STREET, THENCE SOUTHERLY ALONG THE CENTERLINE OF SUMNER STREET TO THE CENTERLINE OF LIBERTY DRIVE, THENCE WESTERLY ALONG THE CENTERLINE OF LIBERTY DRIVE TO THE CENTERLINE OF NAPERVILLE ROAD, THENCE SOUTHERLY ALONG THE CENTERLINE OF NAPERVILLE ROAD TO THE CENTERLINE OF ILLINOIS STREET, THENCE EASTERLY ALONG THE CENTER LINE OF ILLINOIS STREET TO THE CENTERLINE OF WASHINGTON STREET, THENCE SOUTHERLY ALONG THE CENTERLINE OF WASHINGTON STREET TO THE CENTERLINE OF INDIANA STREET, THENCE WESTERLY ALONG THE CENTERLINE OF INDIANA STREET TO THE CENTERLINE OF NAPERVILLE ROAD, THENCE SOUTHERLY ALONG THE CENTERLINE OF NAPERVILLE ROAD TO THE CENTERLINE OF ROOSEVELT ROAD (ILLINOIS STATE ROUTE 38), THENCE WESTERLY ALONG THE CENTERLINE OF ROOSEVELT ROAD TO THE CENTERLINE OF WEST STREET/WARRENVILLE ROAD, THENCE SOUTHERLY ALONG THE CENTERLINE OF WARRENVILLE ROAD TO THE EXISTING CITY OF WHEATON CORPORATE BOUNDARY LINE LOCATED SOUTHERLY OF PLAMONDON COURT, THENCE FOLLOWING THE EXISTING CITY OF WHEATON CORPORATE BOUNDARY LINE WESTERLY, SOUTHERLY AND THENCE NORTHERLY TO ITS INTERSECTION WITH THE SAID CENTERLINE OF THE UNION PACIFIC RAILROAD RIGHT-OF-WAY.

SOUTH CITY COUNCIL ELECTION DISTRICT

ALL OF THAT PART OF THE CITY OF WHEATON, AS INCORPORATED ON OCTOBER 7, 2002, LYING SOUTHERLY, EASTERLY AND WESTERLY OF THE FOLLOWING DESCRIBED LINE: BEGINNING AT THE CENTERLINE OF WARRENVILLE ROAD WITH THE CENTERLINE OF MERRILL DRIVE, THENCE NORTHERLY ALONG THE CENTERLINE OF WARRENVILLE ROAD TO THE CENTERLINE OF ELM STREET, THENCE EASTERLY ALONG THE CENTERLINE OF ELM STREET TO THE CENTERLINE OF NAPERVILLE ROAD, THENCE SOUTHERLY ALONG THE

CENTERLINE OF NAPERVILLE ROAD TO THE CENTERLINE OF TENNYSON DRIVE, THENCE EASTERLY ALONG THE CENTERLINE OF TENNYSON DRIVE TO THE CENTERLINE OF HAVERHILL DRIVE, THENCE NORtherly ALONG THE CENTERLINE OF HAVERHILL DRIVE TO THE CENTERLINE OF FARNHAM LANE, THENCE EASTERLY ALONG THE CENTERLINE OF FARNHAM LANE TO THE CENTERLINE OF PRESIDENT STREET, THENCE SOUTHERLY ALONG THE CENTERLINE OF PRESIDENT STREET TO THE CENTERLINE OF BLANCHARD STREET, THENCE SOUTHERLY ALONG THE CENTERLINE OF BLANCHARD STREET TO THE EXTENSION OF THE SOUTHERLY LINE OF CASA SOLANA SUBDIVISION, A SUBDIVISION IN SECTIONS 27 AND 28, OF SAID TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, THENCE EASTERLY ALONG THE SOUTHERLY LINE OF SAID CASA SOLANA SUBDIVISION AND THE EXTENSION THEREOF TO THE CENTERLINE OF BRIARCLIFFE BOULEVARD, THENCE SOUTHERLY ALONG THE CENTERLINE OF BRIARCLIFFE BOULEVARD TO THE NORtherly LINE OF BRIARCLIFFE UNIT ONE SUBDIVISION, A SUBDIVISION IN THE SOUTHWEST QUARTER OF SECTION 27 IN SAID TOWNSHIP, THENCE EASTERLY ALONG THE NORtherly LINE OF SAID BRIARCLIFFE UNIT ONE SUBDIVISION, TO THE EXISTING CORPORATE LIMITS OF THE CITY OF WHEATON."

Section 2: In all other respects, the terms and provisions of the Wheaton City Code, as amended, are ratified and remain in full force and effect.


Section 3: All ordinances or parts of ordinances in conflict with these provisions are repealed.


