The following changes / clarifications / additions have been added to the Invitation to Bid project specifications and plans:

1. **Attached:** Sign in sheet for mandatory Pre-Bid meeting.
2. **QUESTION:** On page 1, it states that "Illinois Prevailing Wage Act 820 ILCS Does not Apply." However, on page 66 it states that (D) The undersigned certifies that, pursuant to 820 ILCS 130/1-12 of the Illinois Compiled Statutes, the bidder, when required, is in compliance to all requirements of the Prevailing Wage Act. Would you be able to confirm if prevailing wages apply or if they do not?
ANSWER: Illinois Prevailing Wage Act 820 ILCS Does not Apply.
3. **QUESTION:** What are the square footages of the parking garages?
ANSWER: Municipal Parking Garage / Wesley St = 171,000 square feet
Cross Street Parking Garage = 140,836 square feet
4. **QUESTION:** How many chairs/pieces of furniture needs to be done when we do the upholstery cleaning?
ANSWER: The city cannot provide this information at this time. The city has included, within Exhibit A: Facility Availability and Special Requirements page , the number of employees who work in each facility.
