**ORDINANCE NO. F-0910**

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR  
VEHICLE AND TRAFFIC SCHEDULES (CHAPTER 70)  
FOR THE CITY OF WHEATON, ILLINOIS  
(PARKING METER CHANGES)**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

**SECTION 1:** That the Official Motor Vehicle and Traffic Schedule IX. (Parking meter zones; designation of parking spaces) as referred in Section 70-378 of the Wheaton City Code, 1996 as amended, is hereby further amended to read as follows:

(7) Main Street	Both sides from Illinois Street to the alley north of Willow Avenue; west side from Illinois Street to Indiana Street.

(14) Willow Avenue	Both sides from main Street to Wheaton Avenue; north side from Wheaton Avenue to West Street; south side from Reber Street to NapervilleRoad.

**SECTION 2:** That the Official Motor Vehicle and Traffic Schedule X-A (Metered parking areas – on street) as referred in Section 70-382 of the Wheaton City Code, 1996 as amended, is hereby further amended to read as follows:

(a) <u>12 hour limits:</u>

**SECTION 3:** That the Official Motor Vehicle and Traffic Schedule X-C (Metered parking areas – off-street) as referred in Section 70-382 of the Wheaton City Code, 1996 as amended, is hereby further amended to read as follows:

**SECTION 4:** That the Official Motor Vehicle and Traffic Schedule X-D (Leased Parking) as referred in Section 70-413 of the Wheaton City Code, 1996 as amended, is hereby further amended to read as follows:

(8) Parking Lot #6 (North side of Crescent Street west of Hill Avenue), leased parking Monday through Friday: Twenty dollars (\$20.00) per month. Twenty-five dollars (\$25.00) per month for non residents.

**SECTION 5:** That the Official Motor Vehicle and Traffic Schedule VIII. (Parking time (non-metered) limited on certain streets and off-street lots) as referred in Section 70-354(e) of the Wheaton City Code, 1996, as amended, is hereby further amended to read as follows:

III. On-Street Limited Parking Time: In accordance with this section and when proper signs have been erected, parking shall be limited to the maximum time indicated on the following streets or parts of streets the hours of 8:00 a.m. to 6:00 p.m. on Monday through Friday, except legal holidays.

(a) 4 hour limit:

(12) Main Street      East side from Wesley Street to Seminary Avenue.

(13) Seminary Avenue      South side from Main Street to Cross Street.

(14) Wesley Street      South side from West Street to Gary Avenue.

**SECTION 6:** That all ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.


**SECTION 7:** That this ordinance shall become effective from and after its passage, approval and publication in a manner provided by law.
