

ORDINANCE NO. F-1402

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE FISCAL YEAR BEGINNING MAY 1, 2008 AND ENDING APRIL 30, 2009 IN AND FOR THE CITY OF WHEATON SPECIAL SERVICE AREA NUMBER TWO

BE IT ORDAINED BY THE Mayor and City Council of the City of Wheaton, Illinois, pursuant to its home rule powers, as follows:

Section 1: Findings. The City of Wheaton Special Service Area Number Two has been created by an ordinance entitled, "An Ordinance Establishing City of Wheaton Special Service Area Number Two", adopted February 8, 1983, and effective as of February 9, 1983, no petition having been filed opposing the creation of the special service area, pursuant to Public Act 88-455. Special Service Area Number Two consists of the territory described in the ordinance aforesaid. The City of Wheaton is authorized to levy taxes for special services in Special Service Area Number Two.

Section 2: The total amount of appropriations for all the purposes to be collected from the tax levy of the current fiscal year in Special Service Area Number Two is ascertained to be the sum of \$44,165.05.

Section 3: The following sums shall be levied upon the taxable property as defined in Public Act 88-455, in the City of Wheaton Special Service Area Number Two; said tax to be levied for the fiscal year beginning May 1, 2008, and ending April 30, 2009.



Section 4: This tax is levied pursuant to Public Act 88-455 and pursuant to An Ordinance Establishing City of Wheaton Special Service Area Number Two.

Section 5: The \$44,165.05 tax levy is certified to the County Clerk of DuPage County, Illinois. The City of Wheaton determines this \$44,165.05 tax levy to be the total amount required to be raised by taxation for the current fiscal year of the City for Special Service Area Number Two. The City Clerk of Wheaton, Illinois, is ordered and directed to file with the County Clerk of DuPage County, on or before the time required by law, a certified copy of this ordinance.


Section 6: All ordinances or parts of ordinances in conflict with these provisions are repealed.
