

## **ORDINANCE NO. F-1432**

### **AN ORDINANCE AMENDING CHAPTER 18 (ANNEXATION), CHAPTER 74 (UTILITIES), AND APPENDIX B (FEE SCHEDULE) OF THE WHEATON CITY CODE**

BE IT AND IT IS HEREBY ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1: That Chapter 18 (Annexation), of the Wheaton City Code, 1996, is hereby further amended by deleting and replacing Section 18-5 (Fees, costs) with the following:

“Any petition for an annexation agreement or amendment thereto shall be accompanied by a fee of \$400.00. Any further extraordinary costs shall be borne by the petitioner.”

Section 2: That Chapter 74 (Utilities), Article IV (Water Service), Division 2 (Fees), of the Wheaton City Code, 1996, is hereby amended by deleting and replacing paragraph (3) (Tap Fees) (a) (Water main taps), (1) (v) and adding subparagraph (vi) of Section 74-166 (Schedule of fees for connection to water-sewer system), as follows:

“v. The fee for abandoning and plugging of each unused water service, when done at the time a new service tap is made, shall be \$300.00.

vi. The fee for services to be plugged when not in conjunction with a new service tap shall be \$850.00.”

Section 3: That Chapter 74 (Utilities), Article IV (Water Service), Division 3 (Meters), of the Wheaton City Code, 1996, is hereby amended by deleting subparagraph (j) of Section 74-178 (Installation and location of meters, meter readout devices) in its entirety.

Section 4: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-3 (Miscellaneous Administrative Fees), paragraph 5 (Leased Parking Rates), (a) (Central Business District Lot 1 (Parking Garage)) (2) is hereby amended as follows:

“2. Residential \$150.00.”

Section 5: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-5 (Special Event Fees/Extraordinary Services) is hereby amended by deleting and replacing Section B-5 in its entirety as follows:

Section 6: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, is further amended by adding Section B-6 as follows:

<b>B-6</b>	<b>Extraordinary Services</b>
1.	Extraordinary police services \$65.00 Per Hour – 2 Hour Minimum

Section 7: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-3 (Miscellaneous Administrative Fees) (4) is hereby amended by deleting the reference to Section B-5 of the Fee Schedule and replacing it with a reference to Section B-6.

Section 8: That all ordinances or parts of ordinances in conflict with these provisions are repealed.

Section 9: This ordinance shall become effective from and after its passage, approval, and publication in pamphlet form in the manner prescribed by law.
