

ORDINANCE NO. F-1457

AN ORDINANCE AMENDING CHAPTER 18 (ANNEXATION), AND APPENDIX B (FEE SCHEDULE) OF THE WHEATON CITY CODE

BE IT AND IT IS HEREBY ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1: That Chapter 18 (Annexation), of the Wheaton City Code, 1996, is hereby further amended by deleting and replacing Section 18-5 (Fees, costs) with the following:

“Any petition for an annexation agreement or amendment thereto shall be accompanied by a fee of \$400.00. Any further extraordinary costs, in accordance with appendix B of this Code shall be borne by the petitioner.”

Section 2: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-2 (Document Sales), paragraph 1 (Large Copies) is hereby amended by deleting and replacing Section B-2, paragraph 1 in its entirety as follows:

Section 3: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-2 (Document Sales), paragraph 7 (Xerographic copy) is hereby amended by deleting and replacing Section B-2, paragraph 7 in its entirety, renumbering it as paragraph 5 and renumbering the subsequent paragraphs accordingly. The new text for Section B-2, paragraph 5 is as follows:

Section 4: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-2 (Document Sales), paragraph 8 (Photographic Services) is hereby amended by deleting Section B-2, paragraph 8 in its entirety.

Section 5: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-3 (Miscellaneous Administrative Fees) is further amended by adding a new paragraph 7 as follows:

Section 6: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-7 (Community Development Fees (Building, Engineering & Planning Depts.)), paragraph 1 is hereby amended by deleting and replacing Section B-7, paragraph 1 in its entirety as follows:

Section 7: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, Section B-10 (Police Department Fees), paragraph 1 (Administrative fees) (2) is hereby amended by deleting and replacing Section B-10, paragraph 1(2) in its entirety and by adding a new paragraph 1(10) as follows:
