

ORDINANCE NO. F-1570

AN ORDINANCE AMENDING CHAPTER 10 (AMUSEMENTS AND ENTERTAINMENTS), ARTICLE IX (SPECIAL EVENTS), AND APPENDIX B (FEE SCHEDULE) OF THE WHEATON CITY CODE

BE IT AND IT IS HEREBY ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

Section 1: That Chapter 10 (Amusements and Entertainments), Article IX (Special Events), of the Wheaton City Code, 1996, is hereby amended by deleting and replacing Section 10-241 (h) (Fees, costs) with the following:

"(h) Permit fee. The fee for special events permit shall be \$35.00."

Section 2: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, is amended by deleting and replacing Section B-3 (5) and Section B-3 (7) as follows:

Section 4: That Appendix B (Fee Schedule), of the Wheaton City Code, 1996, is further amended by deleting and replacing Section B-5 (2) as follows:


