

**ORDINANCE NO. F-1744**

**AN ORDINANCE AMENDING THE 2013 TAX LEVY  
CONTAINED IN ORDINANCE NO. F-1743**

WHEREAS, the City Council of the City of Wheaton passed an Ordinance No. F-1743 levying taxes for corporate purposes for the fiscal year commencing May 1, 2013 and ending April 30, 2014, for the City of Wheaton; and

WHEREAS, said ordinance has been filed with the County Clerk of DuPage County in accordance with the applicable state statutes; and

WHEREAS, the City of Wheaton has exercised its home rule powers in adopting Ordinance No. E-1279 establishing a general corporate tax levy for the City of Wheaton in lieu of separate levies; and

WHEREAS, the City of Wheaton desires to amend Ordinance No. F-1743.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, Illinois:

Section 1. That the County Clerk of the County of DuPage is hereby authorized and directed to amend the taxes hitherto provided for and levied in Ordinance No. F-1743 so as to reduce the amount heretofore levied.

Section 2. That the bond and interest levy of \$6,547,051 established in Ordinance No. F-1743 be abated as follows:


1. That the amount levied in Ordinance No. F-0994 of \$2,348,400 be abated by \$1,064,000 to \$1,284,400.
2. That the amount levied in Ordinance No. F-1046 of \$1,189,920 be abated by \$1,189,920 to \$0.
3. That the amount levied in Ordinance No. F-1291 of \$792,562 be abated by \$792,562 to \$0.
4. That the amount levied in Ordinance No. F-1645 of \$300,900 be abated by \$300,900 to \$0.

The total amount abated equals \$3,347,382 resulting in a total levy for bond and interest of \$3,199,669.

Section 3. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 4. That the City Clerk is hereby ordered and directed to cause a certified copy of this ordinance to be filed with the County Clerk of DuPage County.

Section 5. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, in the manner provided by law.
