

ORDINANCE NO. F-1831

AN ORDINANCE AMENDING THE 2014 TAX LEVY CONTAINED IN ORDINANCE NO. F-1830

WHEREAS, the City Council of the City of Wheaton passed an Ordinance No. F-1830 levying taxes for corporate purposes for the fiscal year commencing May 1, 2014 and ending April 30, 2015, for the City of Wheaton; and

WHEREAS, said ordinance has been filed with the County Clerk of DuPage County in accordance with the applicable state statutes; and

WHEREAS, the City of Wheaton has exercised its home rule powers in adopting Ordinance No. E-1279 establishing a general corporate tax levy for the City of Wheaton in lieu of separate levies; and

WHEREAS, the City of Wheaton desires to amend Ordinance No. F-1830.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Wheaton, Illinois:

Section 1. That the County Clerk of the County of DuPage is hereby authorized and directed to amend the taxes hitherto provided for and levied in Ordinance No. F-1830 so as to reduce the amount heretofore levied.

Section 2. That the bond and interest levy of \$6,267,623 established in Ordinance No. F-1830 be abated as follows:

1. That the amount levied in Ordinance No. F-0824 of \$575,025 be abated by \$200,000 to \$375,025.
2. That the amount levied in Ordinance No. F-0994 of \$1,029,600 be abated by \$1,029,600 to \$0.
3. That the amount levied in Ordinance No. F-1046 of \$1,255,035 be abated by \$1,255,035 to \$0.
4. That the amount levied in Ordinance No. F-1291 of \$789,719 be abated by \$789,719 to \$0.

The total amount abated equals \$3,274,354 resulting in a total levy for bond and interest of \$2,993,269.

Section 3. That all ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section 4. That the City Clerk is hereby ordered and directed to cause a certified copy of this ordinance to be filed with the County Clerk of DuPage County.

Section 5. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, in the manner provided by law.
