Engineering Services – Guardrail Modernization

Solicitation Process: RFP to qualified engineering firms

Recommended Vendor: Primera Engineers

The adopted FY 2017 Capital Projects Fund budget includes a total of \$30,000 for guardrail modernization:

Budget: **\$30,000**

Request for Purchase: **\$35,675**

Budget Deficit: **\$ 5,675**

Background: The city's decision to purchase the above service is based on the following:

- The City of Wheaton must update and maintain safety features such as guard rails on local roads.
- A professional engineering design firm is needed to perform field evaluation and analysis of guardrail infrastructure at 19 locations within the City to determine the required improvements necessary to meet Department of Transportation standards.
- A professional engineering design firm will also need to develop plans and specifications for bidding for one of these locations.
- RFP notices were published on the city website RSS feed, Public Purchase and Oniva's DemandStar.
- Nine (9) prequalified vendors were emailed the bid notice.
- Three (3) proposals were received.
- All bids came in over the project budget; ranging in cost from \$35,675 to \$45,843.
- The lowest responsible bidder is Primera Engineers.
- Procurement recommends awarding a contract to Primera Engineers due to the necessity of the project.
