
**WHEREAS**, the City has a continued need for engineering services Phase 3 construction resident engineer services; and

**AMENDMENT #1 OF CONTRACT #C 36936  
Agreement between the City of Wheaton, Illinois  
and STRAND ASSOCIATES, INC.,  
for DESIGN ENGINEERING SERVICES PHASE 3 CONSTRUCTION RESIDENT ENGINEER  
SERVICES**

This first amendment to City Agreement #C 36936, a copy of which is attached hereto and incorporated herein as if fully set forth as Exhibit A-Amendment #1, is entered into as of this 19th day of March 2018 by and between the CITY OF WHEATON, an Illinois municipal corporation ("City"), 303 West Wesley Street, Wheaton, IL 60187, and STRAND ASSOCIATES, INC., ("Professional Service Provider"), 1170 South Houbolt road, Joliet, IL 60431.

**WHEREAS**, the City and the Professional Service Provider entered into City Agreement #C 36936, dated April 17, 2017, to provide services (hereinafter the "Work") described as design engineering services phase 3 construction resident engineer services consistent with Exhibit A of the initial contract; and

**WHEREAS**, the City has a continued need for Engineering Services Phase 3 Construction Resident Engineer Services; and

**WHEREAS**, the City received a proposal dated March 7, 2018, a copy of which is attached hereto and incorporated herein as if fully set forth as Exhibit B-Amendment #1, from Strand Associates, Inc., for continued Engineering Services Phase 3 Construction Resident Engineer Services through September 30, 2018.

**NOW, THEREFORE**, in consideration of the agreements contained in this instrument and such other sufficient considerations, the parties agree as follows:

1. The recitals set forth above, including Exhibit A-Amendment #1 and Exhibit B-Amendment #1, are incorporated herein as substantive terms and conditions of this Amendment #1 of Contract #C36936 and represent the intent of the parties.
2. The City retains the Professional Service Provider to perform, and the Professional Service Provider agrees to perform all Engineering Services Phase 3 Construction Resident Engineer Services described in Exhibit A-Amendment #1 and as amended by Exhibit B-Amendment #1.
3. All other provisions of Agreement #C36936, except as modified herein, are hereby ratified and reaffirmed.
