WHEREAS, the City of Wheaton, DuPage County, Illinois and Thomas Engineering Group entered into an Agreement dated March 10, 2016, to provide surface transportation program design engineering services (City Agreement #C 36844, herein after "Agreement"); and


WHEREAS, the City has a continued need for surface transportation program design engineering services; and



AMENDMENT #1 OF CONTRACT #C 36844
Agreement between the City of Wheaton, Illinois
and THOMAS ENGINEERING GROUP
for SURFACE TRANSPORTATION PROGRAM DESIGN ENGINEERING SERVICES

This first amendment to City Agreement #C 36844, a copy of which is attached hereto and incorporated herein as if fully set forth as Exhibit A-Amendment #1, is entered into as of this 19th day of March 2018 by and between the CITY OF WHEATON, an Illinois municipal corporation ("City"), 303 West Wesley Street, Wheaton, IL 60187, and THOMAS ENGINEERING GROUP, ("Professional Service Provider"), 55 West 22nd Street, Suite 300, Lombard, IL 60148.

WHEREAS, the City and the Professional Service Provider entered into City Agreement #C 36844, dated March 10, 2016, to provide services (hereinafter the "Work") described as Surface Transportation Program Design Engineering Services consistent with Exhibit A of the initial contract; and


WHEREAS, the City has a continued need for Surface Transportation Program Design Engineering Services; and

WHEREAS, the City received a proposal dated March 5, 2018, a copy of which is attached hereto and incorporated herein as if fully set forth as Exhibit B-Amendment #1, from Thomas Engineering Group for continued Surface Transportation Program Design Engineering through December 31, 2019.

NOW, THEREFORE, in consideration of the agreements contained in this instrument and such other sufficient considerations, the parties agree as follows:

1. The recitals set forth above, including Exhibit A-Amendment #1 and Exhibit B-Amendment #1, are incorporated herein as substantive terms and conditions of this Amendment #1 of Contract #C36844 and represent the intent of the parties.
2. The City retains the Professional Service Provider to perform, and the Professional Service Provider agrees to perform all Surface Transportation Program Design Engineering Services described in Exhibit A-Amendment #1 and as amended by Exhibit B-Amendment #1.
3. All other provisions of Agreement #C36844, except as modified herein, are hereby ratified and reaffirmed.


