

ORDINANCE NO. O-2018-16

**AN ORDINANCE AMENDING SECTION 2-561 "FISCAL YEAR ESTABLISHED" and
SECTION 2-567 (c) "APPLICATION FOR PUBLIC FUNDS" OF ARTICLE IX
(FINANCE), CHAPTER 2 (ADMINISTRATION) OF THE WHEATON CITY CODE**

WHEREAS, the City of Wheaton, Illinois ("city") is an Illinois home rule municipality pursuant to provisions of Article VII, Section 6, of the Illinois Constitution, 1970, and as such the city may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the fiscal year for the city now begins on the first day of May of each year and ends on the last day of April on the following year; and

WHEREAS, the corporate authorities of the city have determined that it is in the best fiscal interests of the city to change the fiscal year so that the next fiscal year would cover an eight-month period running from May 1, 2018 through December 31, 2018, and thereafter the fiscal year would coincide with the calendar year.

BE IT AND IT IS HEREBY ORDAINED by the Mayor and City Council of the City of Wheaton, DuPage County Illinois, pursuant to its home rule authority as follows:

Section 1: That Section 2-561 "Fiscal Year Established," of Article IX (Finance) of Chapter 2 (Administration), is hereby repealed and rescinded in its entirety and replaced with a new Section 2-561 which shall read as follows:

Section 2-561 "Fiscal Year Established"


- (a) Commencing May 1, 2018, the fiscal year for the city shall begin on the first day of May 2018 and shall end on the last day of December 2018; and
- (b) Commencing January 1, 2019, the fiscal year for the city shall begin on the first day of January of each year and shall end on the last day of December of the same calendar year.

Section 2: That Section 2-567(c) "Application for public funds" of Section 2-567 "Criteria and Standards for the payment of public funds for specific public purposes" of Article IX (Finance), Chapter 2 (Administration), of the Wheaton City Code is hereby repealed and rescinded in its entirety and replaced with a new Section 2-567(c) which shall read as follows:

- (c) *Application for public funds.* Any entity meeting the criteria and standards provided for in this section may apply to the city for receipt of public funds by completing the application customarily in force and effect at the city and filing the application with the office of the city manager. Said applications shall be filed by August 1 of each year for funding consideration in the city's next fiscal year.

Section 3: That all ordinances or parts of ordinances in conflict with these provisions are repealed.

Section 4: This ordinance shall become effective from and after its passage, approval, and publication in pamphlet form in the manner prescribed by law.
