

**ORDINANCE NO. F- O-2018-23**

**AN ORDINANCE AMENDING CITY OF WHEATON ORDINANCE NUMBER E-3495 "AN ORDINANCE GRANTING A SPECIAL USE PERMIT FOR AN OFFICE BUILDING ON THE PROPERTY LOCATED AT THE SOUTHEAST CORNER OF ROOSEVELT ROAD AND NAPERVILLE ROADS AND COMMONLY KNOWN AS 300 EAST ROOSEVELT ROAD – RATHJE, WOODWARD, DYER & BURT"**

**WHEREAS**, on May 1, 1989, the City of Wheaton, Illinois ("City"), enacted City Ordinance No. E-3459, recorded on April 20, 1990, as Document No. R90-47537, at the DuPage County Recorder of Deeds Office, "AN ORDINANCE GRANTING A SPECIAL USE PERMIT FOR AN OFFICE BUILDING ON THE PROPERTY LOCATED AT THE SOUTHEAST CORNER OF ROOSEVELT ROAD AND NAPERVILLE ROADS AND COMMONLY KNOWN AS 300 EAST ROOSEVELT ROAD – RATHJE, WOODWARD, DYER & BURT" ("Original Ordinance") which granted a special use permit, all on certain property legally described herein as Exhibit "A" and located within the city limits of Wheaton, Illinois ("City"); and

**WHEREAS**, following the enactment of the Original Ordinance, an application has been made to amend the approved sign restrictions to replace the approved, existing sign with a new sign and the City has determined that the requested amendment is a minor amendment and may be implemented without public hearing, pursuant to the provisions of the Wheaton Zoning Ordinance.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Wheaton, Du Page County, Illinois, pursuant to its home rule powers, as follows:


**Section 1:** Pursuant to the Findings of Fact made and determined by the Wheaton City Council, Section 2C the Original Ordinance is hereby repealed and replaced with the following: "Any ground sign on the property shall be in compliance with the requirements of the City of Wheaton Zoning Ordinance."

**Section 2:** In all other respects, the terms, conditions and provisions of the Original Ordinance are ratified and remain in full force and effect.

**Section 3:** All ordinances or parts of ordinances in conflict with these provisions are repealed.

**Section 4:** This ordinance shall become effective from and after its passage, approval, and publication in pamphlet form in the manner prescribed by law.
