

ORDINANCE NO. O-2019-01

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR VEHICLE
AND TRAFFIC SCHEDULES (CHAPTER 70)
FOR THE CITY OF WHEATON**

BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois as follows:

SECTION 1: That the Official Motor Vehicle and Traffic Schedule V, (Yield right of way intersections), as referred in Section 70-307 of the Wheaton City Code, 2016, as amended, is hereby amended by repealing and rescinding said Schedule V in its entirety and replacing it to read as follows:

"Schedule V. Yield right of way intersections. (Sec. 70-307)

In accordance with the provisions of Section 70-307 and when signs are erected giving notice thereof, traffic traveling upon the following streets or portion thereof and approaching the following intersecting streets, shall yield the right-of-way to other traffic at said intersections as hereinafter set forth:


- (1) Crest Street shall yield to Arbor Avenue.
- (2) Cherry Street shall yield to Forest Avenue.
- (3) Madison Avenue shall yield to Cross Street.
- (4) Cheshire Lane shall yield to Sheffield Lane.
- (5) Cheshire Lane shall yield to Windsor Drive.
- (6) Liberty Drive shall yield to Woodlawn Street.
- (7) Nottingham Lane shall yield to Windsor Drive.
- (8) Willow Avenue shall yield to southbound Blanchard Street.
- (9) Willow Avenue shall yield to northbound Blanchard Street.
- (10) Blanchard Street shall yield to eastbound Willow Avenue.
- (11) James Court shall yield to Arbor Avenue.
- (12) Liberty Drive shall yield to Dorchester Avenue.
- (13) Lakeside Drive shall yield to Woodlawn Street.

- (14) North Path shall yield to Webster Avenue.
- (15) Webster Avenue shall yield to Forest Avenue.
- (16) Wakeman Avenue shall yield to Summit Street.
- (17) Carlton Avenue shall yield to Lincoln Avenue.
- (18) Wheaton Avenue shall yield to Prairie Avenue.
- (19) Liberty Drive shall yield to Morgan Avenue.
- (20) Williston Street shall yield to Coolidge Avenue.
- (21) Cross Street shall yield to Jefferson Street.
- (22) Prospect Street shall yield to Pershing Avenue.
- (23) Campbell Avenue shall yield to Evergreen Street.
- (24) Howard Street shall yield to Forest Avenue.
- (25) Cross Street shall yield to Forest Avenue.
- (26) Sumner Street shall yield to Liberty Drive.
- (27) Williston Street shall yield to Evergreen Street.
- (28) Summit Street shall yield to Liberty Drive.
- (29) Williams Street shall yield to Beverly Avenue.
- (30) Tennyson Drive shall yield to Gamon Road.
- (31) Oak Street shall yield to Washington Street.
- (32) Commerce Drive shall yield to Gables Boulevard.
- (33) Gladstone Drive shall yield to Somerset Lane.
- (34) Eastbound Blanchard Street shall yield to northbound Blanchard Street.
- (35) Cheshire Lane shall yield to Brentwood Lane.

- (36) Coolidge Avenue shall yield to Prospect Avenue.
- (37) Lexington Street shall yield to Oak Avenue.
- (38) *Lexington Street shall yield to Forest Avenue.*
- (39) *North Path shall yield to Blanchard Street.*
- (40) *North Path shall yield to Summit Street.*
- (41) *Wilmette Street shall yield to Thomas Road.*
- (42) *Lakeside Drive shall yield to Knollwood Drive.*
- (43) *Sunset Road/Lyford Lane shall yield to Gables Boulevard.*
- (44) *Campbell Avenue shall yield at Indiana Street.*
- (45) *Williston Street shall yield to Wilson Avenue.*
- (46) *Wilson Avenue shall yield to Prospect Avenue.*
- (47) *Hampton Drive shall yield to Chatham Drive.*
- (48) *Middleton Drive shall yield to Somerset Lane.*
- (49) *Buckingham Drive shall yield to Richton Drive.*
- (50) *Marywood Trail/Jeffery Court shall yield to Somerset Lane."*

SECTION 2: That all ordinances or parts of ordinances in conflict with provisions of this Ordinance are hereby repealed.

SECTION 3: That this Ordinance shall become effective from and after its passage, approval, and publication provided by law.
