**AN ORDINANCE AMENDING ORDINANCE NO. F-2028 "AN ORDINANCE APPROVING A PLAT OF CONSOLIDATION, AMENDING THE WHEATON ZONING MAP AND GRANTING A SPECIAL USE PERMIT FOR A PLANNED UNIT DEVELOPMENT LOT 7 AND 8 LORETTO CLUB GOLDSBOROUGH"**

**WHEREAS**, on August 7, 2017, the Wheaton City Council approved Ordinance No. F-2028 "AN ORDINANCE APPROVING A PLAT OF CONSOLIDATION, AMENDING THE WHEATON ZONING MAP AND GRANTING A SPECIAL USE PERMIT FOR A PLANNED UNIT DEVELOPMENT LOT 7 AND 8 LORETTO CLUB GOLDSBOROUGH" ("Original Ordinance"); and

**WHEREAS**, following the enactment of the Original Ordinance, application has been made to further amend the PUD Plan to accommodate a revised attached garage plan.

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and City Council of the City of Wheaton, DuPage County, Illinois, pursuant to its home rule powers as follows:

**Section 1:** The real property, legally described in Exhibit A, which is attached hereto and incorporated herein, has been and continues to be zoned in the I-1 Institutional Zoning District classification, with a special use permit for a Planned Unit Development.

**Section 2:** The site plan, entitled 141 Loretto Court, Site Development Plan – Phase 2, prepared by Cemcon, Ltd. Dated 8-15-17 bearing a latest revision date of 05-13-19, attached as Exhibit B, is hereby approved.

**Section 3:** This ordinance shall become effective after its passage, approval and publication in pamphlet form in the manner described by law.


