**RESOLUTION R-2019-74**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 77 WITH  
STEVE PIPER AND SONS FOR TREE PRUNING SERVICES FOR A TOTAL  
AMOUNT NOT TO EXCEED \$60,000.00**

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Steve Piper and Sons, 31W320 Ramm Drive., Naperville, Illinois, 60564, for Tree Pruning Services; and

**WHEREAS**, the City prepared a bid package (Bid Number 19-65) that included Tree Pruning Services; and

**WHEREAS**, the City budgeted funds in the General Fund in the amount of \$60,000.00 for Tree Pruning Services for the Public Works Forestry Division; and

**WHEREAS**, the City solicited bids in a public bidding process and bids were publicly opened and read on July 17, 2019, at 11:00AM and Steve Piper and Sons was determined to be the lowest, responsive, responsible bidder; and

**WHEREAS**, it is necessary for the City to enter into an agreement with Steve Piper and Sons for Tree Pruning Services; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Tree Pruning Services.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois that the Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to an agreement between the City of Wheaton and Steve Piper and Sons, 31W320 Ramm Drive., Naperville, Illinois, 60564 for a total amount not to exceed of \$60,000.00 for Tree Pruning Services.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that the Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 77 with Steve Piper and Sons, 31W320 Ramm Drive., Naperville, Illinois, 60564, for Tree Pruning Services, for a total amount not to exceed \$60,000.00, and that a copy of that certain City of Wheaton Agreement No. 77 is on file with the City Clerk's office and is hereby incorporated into this Resolution as if fully set forth herein.
