

**RESOLUTION R-2019-80**

**A RESOLUTION AUTHORIZING THE PURCHASE OF THREE REPLACEMENT POLICE VEHICLES  
FROM CURRIE MOTORS COMMERCIAL CENTER THROUGH THE JOINT PURCHASING PROGRAM  
WITH SUBURBAN PURCHASING COOPERATIVE FOR A TOTAL AMOUNT OF \$103,748.00**

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, et seq.), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the Suburban Purchasing Cooperative (SPC) has publicly and competitively bid for Ford Utility Interceptor SUVs; and


**WHEREAS**, the SPC awarded Contract #152 to Currie Motors Commercial Center in Frankfort, Illinois, for Ford Utility Interceptor SUVs and has made the contract available to other public entities; and

**WHEREAS**, the corporate authorities of the City of Wheaton find it reasonable and appropriate to purchase three 2020 Ford Utility Interceptor SUVs, including one unit in a hybrid-electric configuration, for a total amount not to exceed \$103,748.00 on the SPC Contract #152 as replacement vehicles for the Patrol Division of the Police Department.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

- a) The City's Purchase Order #P37148 for the purchase of three 2020 Ford Utility Interceptor SUVs through the Suburban Purchasing Cooperative (SPC) Contract #152 from Currie Motors Commercial Center in Frankfort, Illinois, for a total amount not to exceed \$103,748.00, for the Patrol Division of the Police Department is hereby authorized (the "Purchase"); and
- b) A copy of the City's Purchase Order #P37148 is on file with the City Clerk's office as Exhibit A to this Resolution R-2019-80 and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and
- c) A copy of the SPC Contract #152 is on file with the City Clerk's office as Exhibit A to Purchase Order #P37148, and is hereby incorporated into this Resolution and made a part hereof as if fully set forth herein; and
- d) City staff is authorized to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
