**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 86 WITH
WEBSTER, MCGRATH & AHLBERG, LTD. FOR THE FLOODPLAIN PROPERTIES SURVEY PROJECT-
PHASE II FOR A TOTAL AMOUNT NOT TO EXCEED \$51,940.00**

WHEREAS, the corporate authorities of the City of Wheaton ("City"), DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Webster, McGrath & Ahlberg, Ltd., 207 S. Naperville Road, Wheaton, Illinois, 60187, for the Floodplain Properties Survey Project- Phase II; and

WHEREAS, the City prepared a Request for Quotation package (RFQ Number 19-93) that included the Floodplain Properties Survey Project- Phase II; and

WHEREAS, the City budgeted funds in the Storm Sewer Capital Projects Fund in the amount of \$100,000.00; and

WHEREAS, the City conducted a Request for Proposal for the Floodplain Properties Survey Project- Phase I project in 2018 and engaged Webster, McGrath & Ahlberg, Ltd. to provide the requested services as its proposal met the City's needs. Webster, McGrath & Ahlberg, Ltd. has proposed to provide the requested services for Phase II at the same terms and conditions and pricing as Phase I; and

WHEREAS, both parties agree to the terms and conditions set forth in the RFQ and the agreement contained in the City's RFQ package for the Floodplain Properties Survey Project- Phase II.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 86 with Webster, McGrath & Ahlberg, Ltd., 207 S. Naperville Road, Wheaton, Illinois, 60187, for the Floodplain Properties Survey Project-Phase II for a total amount not to exceed \$51,940.00; and that a copy of that certain City of Wheaton Agreement No. 86 is on file with the City Clerk's office as Exhibit A to this Resolution R-2019-87 and is hereby incorporated into this Resolution as if fully set forth herein.
