

RESOLUTION R-2019-94

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 89 WITH
P.R. STREICH AND SONS, INC. FOR VEHICLE PIT LIFT IMPROVEMENTS
AND A TOTAL AMOUNT NOT TO EXCEED \$192,678.00**

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with P.R. Streich and Sons, Inc., 2333 17th Street, Franklin Park, Illinois, 60131, for Vehicle Pit Lift Improvements; and

WHEREAS, the City prepared a bid package (Bid Number 19-87) that included Vehicle Pit Lift Improvements; and

WHEREAS, the City budgeted funds in the Fleet Services Fund in the amount of \$160,000.00 for Vehicle Pit Lift Improvements for the Public Works Fleet Division. The Fleet Services Fund has the reserves available to accommodate the additional cost; and

WHEREAS, the City solicited bids in a public bidding process and bids were publicly opened and read on September 20, 2019, at 11:00AM and P.R. Streich and Sons, Inc. was determined to be the lowest, responsive, responsible bidder; and

WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Vehicle Pit Lift Improvements.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 89 with P.R. Streich and Sons, Inc., 2333 17th Street, Franklin Park, Illinois, 60131, for Vehicle Pit Lift Improvements at the pricing set forth in P.R. Streich and Sons, Inc.'s Cost Proposal, which is incorporated into City of Wheaton Agreement No. 89, through April 30, 2020; and that a copy of that certain City of Wheaton Agreement No. 89 is on file with the City Clerk's office as Exhibit A to this Resolution R-2019-94 and is hereby incorporated into this Resolution as if fully set forth herein.
