The Wheaton Police Department completed a purchase of new portable breath instruments in September 2019 to replace a portion of our current inventory. S-D2 Portable Breath Instruments #16, 27, 30, 35, 36, 37, 38, 40, 41, 42, 43, 45, 46, 47, 48, and 49 were identified as obsolete units, as their fuel cells eclipsed the recommended replacement range of 7-10 years, according to the units manufacturer, CMI Incorporated.

I am requesting permission to dispose of the S-D2 Portable Breath Instruments listed above as they no longer have practical utility or resale value.
