RESOLUTION R-2019-108

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 97 WITH
CHICAGOLAND PAVING CONTRACTORS, INC., FOR HOT MIX ASPHALT PAVEMENT REMOVAL
SERVICES FOR A TOTAL AMOUNT NOT TO EXCEED \$55,000.00**

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Chicagoland Paving Contractors, Inc., 225 Telser Rd., Lake Zurich, Illinois, 60047, for Hot Mix Asphalt Pavement Removal Services; and

WHEREAS, the City prepared a bid package (Bid Number 19-101) that included Hot Mix Asphalt Pavement Removal Services; and

WHEREAS, the City budgeted funds in the General Fund in the amount of \$55,000.00 for Hot Mix Asphalt Pavement Removal Services for the Streets Division of the Public Works Department; and

WHEREAS, the City solicited bids in a public bidding process and bids were publicly opened and read on November 1, 2019, at 11:00AM and Chicagoland Paving Contractors, Inc., was determined to be the lowest, responsive, responsible bidder; and

WHEREAS, both parties agree to the terms and conditions set forth in the bid proposal and the agreement contained in the City's bid package for Hot Mix Asphalt Pavement Removal Services.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 97 with Chicagoland Paving Contractors, Inc., 225 Telser Rd., Lake Zurich, Illinois, 60047, for Hot Mix Asphalt Pavement Removal Services at the pricing set forth in Chicagoland Paving Contractors, Inc.'s Cost Proposal, which is incorporated into City of Wheaton Agreement No. 97; and that a copy of that certain City of Wheaton Agreement No. 97 is on file with the City Clerk's office as Exhibit A to this Resolution R-2019-108 and is hereby incorporated into this Resolution as if fully set forth herein.
