

**RESOLUTION R-2020-09**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 98 WITH  
PRIMERA ENGINEERING, LTD., FOR DESIGN SERVICES FOR PHASE 4 OF THE DOWNTOWN  
STREETSCAPE PROJECT AND FOR A TOTAL AMOUNT NOT TO EXCEED \$1,271,028**

**WHEREAS**, the corporate authorities of the City of Wheaton ("City"), DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Primera Engineering, Ltd., 100 South Wacker Drive, Suite 700, Chicago, Illinois, 60606, for Design Services for Phase 4 of the Downtown Streetscape Project; and

**WHEREAS**, Primera Engineering, Ltd. provided professional engineering services for the Downtown Streetscape Project Phase 1, Phase 2, and Phase 3; and

**WHEREAS**, Primera Engineering, Ltd.'s partnership with City staff, professional experience and qualifications and recent performance and quality of work for Phase 1, Phase 2, and Phase 3 was excellent; and

**WHEREAS**, the City budgeted funds in the TIF District #2 Fund in the amount of \$1,019,043 and \$100,000 in the 2018 G.O. Bond Fund for Design Services for Phase 4 of the Downtown Streetscape Project; and

**WHEREAS**, it is determined by the City that the proposal received from Primera Engineering, Ltd. meets the City's needs; and

**WHEREAS**, it is appropriate for the City to enter into an agreement with Primera Engineering, Ltd. for the purpose of providing design services to the City.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 98 with Primera Engineering, Ltd., 100 South Wacker Drive, Suite 700, Chicago, Illinois, 60606, for Design Services for Phase 4 of the Downtown Streetscape Project at the pricing set forth in Primera Engineering, Ltd.'s Cost Proposal, which is incorporated into City of Wheaton Agreement No. 98; and that a copy of that certain City of Wheaton Agreement No. 98 is on file with the City Clerk's office as Exhibit A to this Resolution R-2020-09 and is hereby incorporated into this Resolution as if fully set forth herein.
